SANDBAG STATIONS OPEN FOR ROCK COUNTY RESIDENTS

The Rock County Sheriff's office shared a news release stating that Rock County is starting to experience flooding due to rain and snowmelt. In partnership with Rock County Public Works - Highway Division, sandbags and sand have been placed for residents to begin preparations. Access to sandbags and sand will be available for Rock County residents at the following locations at no cost:

• Rock Town Hall: Sand and sandbags will be available at the Rock Town Hall at 5102 S CTH D, Afton WI. Residents will need to fill and transport their own bags.

• Newville Park and Ride: Sand and sandbags will be available at the Newville Park and Ride located off I-39/90 at exit 163. Residents will need to fill and transport their own bags.

• **City of Janesville**: The City of Janesville is providing sandbags for Rock County residents at 900 N. Parker Drive. At this time, residents must call the City Services Center at 608-755-3110 to schedule pickup between 7:00 am and 3:00 pm, Monday through Friday. Hours may be extended should the demand for sandbags continue or the flooding risk be prolonged. The City also provides sand at Dawson Softball Complex (920 Beloit Avenue), but residents must bring their own bags and shovels.

• Town of Beloit: The Town of Beloit is providing sand and sandbags to Town of Beloit residents at two locations: 3444 S Riverside Dr. and the Town Hall located at 2871 S Afton Rd. Residents will need to fill and transport their own bags.

• **City of Beloit**: The City of Beloit is providing sandbags for Beloit residents at 2351 Springbrook Court. Residents can pick up at this location. Please call 608-364-2929 with any questions regarding pickup.

The Rock County Sheriff's Office reminds citizens to please stay off roadways that may be closed due to high waters. High water locations and road closures can be monitored at <u>http://www.co.rock.wi.us/highway</u>. Citizens should not try to travel through any roadway covered with water. Please report any immediate, hazardous conditions related to flooding to Rock County Communications at 608-757-2244.

All other concerns related to the potential flooding should be reported to the respective townships or through the Rock County Sheriff's Office – Emergency Management Bureau at 608-758-8440. Citizens are responsible for proper disposal of their own sandbags after use.

SLOW-NO-WAKE DECLARED ON ROCK RIVER

The Sheriff's office is proving public notice of the Rock River's current slow-no-wake status. Deputies will place slow-no-wake signs along the river at all public access points between the W B R Town Line Road Bridge and the Stateline.

At this time the Rock River is under a slow-no-wake restriction south of the Indianford Dam.

4. PUBLIC HEARINGS

- a. Consideration of Ordinance No. 3641 approving a Zoning Map Amendment from temporary R-1A, Single Family Residential District, to permanent R-1A, Single Family Residential District, for the property located at 1014 W. Froebel Drive. Plan Commission recommendation for approval 6-0. First reading. The subject property is privately owned and was annexed/attached in order to connect their existing single-family home with a failing septic system to the City's sanitary sewer. Planning staff has notified the owners of this permanent zoning request, which will not affect the allowable uses of the property.
- b. Consideration of Resolution 2019-021 approving a Planned Unit Development (PUD) Master Land Use Plan for the properties located at 1003, 1017, & 1021 Fourth Street, 117 Merrill Street, and 1016 Third Street. Plan Commission recommendation for approval 6-0, subject to the six conditions recommended by Planning staff, deemed necessary for the public interest. (Those conditions are spelled out in the resolution.) The proposed redevelopment includes demolition of all existing structures and surface parking lots followed by construction of a 7,200 square-foot retail building and 29 off-street parking stalls. The applicant is seeking approval of a PUD in order to provide flexibility in building and driveway placement and to facilitate compliance with the floodplain ordinance requirements.
- c. Consideration of an Ordinance No. 3644 amending the Zoning District Map from C-3, Community Commercial District to PUD, Planned Unit Development District for the properties located at 1003, 1017, and 1021 Fourth Street and 117 Merrill Street and from R-3, Low-Density Multifamily Residential District to PUD for the property located at 1016 Third Street. Plan Commission recommendation for approval 6-0. First reading. The Comprehensive Plan's Future Land Use Map recommends Planned Mixed Use redevelopment of the subject properties, which contemplates the redevelopment and improvement of this important commercial corridor with an emphasis upon mixing land uses, vitality, and walkability.

6. CONSENT AGENDA

All items listed under the Consent Agenda are considered routine and will be enacted by one motion. There will be no separate discussion of these items unless a Council member so requests, in which event the item will be removed from the General Order of Business and considered at this point on the agenda.

- a. Consideration of Resolution 2019-022 approving the release of a platted easement on Lot 56 Eagles Ridge Plat No. 3. Plan Commission recommendation for approval 6-0. This request comes from New Leaf Construction. When the Eagles Ridge Subdivision was platted, the approved plat included 10 foot utility easements along many interior and rear lot lines, which were intended to provide internal utility connections as the lots were individually developed. The request is to reduce the east side lot easement from 10 feet to be 8 feet. The foundation was poured 1 foot into the easement. The applicant is requesting 2 foot release of easement to clean up the easement encroachment. The home complies with all zoning setbacks.
- b. Consideration of Resolution 2019-023 approving the agreement between the City of Beloit and the Community Development Authority (CDA) related to the provision of services to the CDA. In 1983, the CDA contracted with the City of Beloit for a number of services. This agreement was subsequently amended in 2002 and 2003. This agreement is being updated to reflect the current services being provided by the City to the CDA, including (but not limited to): employment services, audit services, legal services, insurance, information technology services, and police services.
- c. Consideration of Resolution 2019-009 approving the Turtle Creek Park Master Plan. Plan Commission recommendation for approval 6-0. The Master Plan is a 5-phase plan which includes painting the existing bathhouse (future plans include demolition of building), construction of a park facility, a new entrance road off of St. Paul Avenue, signage, addition of new equipment, additional parking, and an art installation to commemorate the history of the park.
- d. Consideration of Resolution 2019-017 Approving Phase 1 Improvements in Turtle Creek Park, specifically the construction of an open air pavilion and new parking area. Plan Commission recommendation for approval 5-0. Wisconsin Statutes require Plan Commission to make a recommendation to City Council for any new structures and parking areas on public lands. Turtle Creek Park was designated as a local landmark in 1998 due to its role as a gathering place for the Beloit African-American community in the mid-twentieth century.
- e. Referral to Plan Commission: Application for a Zoning Map Amendment from PUD, Planned Unit Development District, to R-1B, Single Family Residential District, for the properties located at 836 and 842 Park Avenue. This application is from Beloit College. They would like to sell the properties, which are no longer being used as student housing. The College's request is consistent with the Future Land Use Map.
- f. Consideration of Resolution 2019-026 approving Change of Agent on the Class "B" Beer and "Class B" Intoxicating Liquor License for Beloit Professional Baseball Association, Inc., d/b/a Beloit Snappers, located at 2301 Skyline Drive, from Steven Tyler Unser to Jeffrey R. Gray for the Licensing period ending June 30, 2019. ABLCC recommendation for approval 5-0.
- g. Consideration of Resolution 2019-019 authorizing final payment for Public Works Contract C18-14, Roof replacement for Rotary River Center, Cemetery Office, Pump House, and Angel Museum. The requirements of the contract have been completed to the satisfaction of the City. Final payment is recommended.
- h. Consideration of Resolution 2019-028 awarding Public Works contract C19-21, Sewer and Water Maintenance Contract. This is a contract that includes a variety of work related to the installation and/or emergency repairs and maintenance of the water, sanitary sewer and storm sewer infrastructure. Two bids were received for this contract, with the lowest bid submitted by E & N Hughes Co., Inc. Staff recommends the award of contract C19-21 to E & N Hughes Co., Inc.
- i. Consideration of Preliminary Resolution 2019-029 declaring intent to exercise special assessment police powers for Public Works Contract C19-10, Froebel Sanitary Sewer Extension. This project will install sanitary sewer along Froebel

Drive allowing the property at 1014 Froebel to connect to City sewer. This property is within the City limits and is served with City water but not sanitary sewer. The entire sewer extension will serve a total of three parcels. A public hearing and final resolution will follow.

 ABLCC recommendation for approval 5-0. The additional space requested includes an enclosed batting practice structure and fenced in concourse on the left field side along Skyline Drive.
