# MEETING MINUTES BELOIT LANDMARKS COMMISSION Tuesday, November 20, 2018, 7:00 PM The Fourth Floor Conference Room, 100 State Street Beloit, WI 53511

#### 1. Roll Call

Commissioner Blazer called the meeting to order at 7:02 PM. Commissioners Blazer, McGrath, Truesdale, Beckman, Jacobsen, and Councilor Anderson were present. Commissioner Gallagher was absent.

# 2. Minutes of the October 16, 2018 Meeting

Commissioner Beckman moved to approve the draft Minutes. Commissioner McGrath seconded the motion. The motion passed, voice vote.

## 4. Miguel Cepeda - Certificate of Appropriateness

COA-2018-35 Review and consideration of a Certificate of Appropriateness to replace soffit and fascia at the residential structure located at 726 Bluff Street.

Hilary Rottmann, Planner II of Planning & Building Services, read the staff report. Mr. Cepeda requested if he could add the removal of asphalt siding to repair and paint the wood siding that is currently underneath the asphalt siding. Commissioner McGrath wanted to clarify that the he would be happy to approve the additional request but this approval would not allow asphalt, vinyl, or any substitute materials for siding. Discussion was had over if the property had decorative brackets on the home. Mr. Cepdeda also requested that one of the two front doors (the northern most) be converted into a window. Commissioner McGrath was in favor of the door conversion but would like Mr. Cepeda to come back to the Landmarks Commission with specifications of the design of the window. The Commission requested the deadline of the Certificate of Appropriateness be amended to allow a year to complete. Commissioner Beckman moved to approve the Certificate of Appropriateness with the additions of the asphalt siding removal and wood siding being repaired and painted. And the northern most front door converted to a window but the applicant must come back to the commission for approval of the specifications. The approval was subject to the conditions recommended by staff. Commissioner McGrath seconded the motion. The motion passed, voice vote.

- A. Report on Staff-Approved Certificates of Appropriateness. Mrs. Rottmann listed three (3) staff-approved projects since the October meeting. Also provided an update on ownership changes for historic properties.
