#### I-39/90 EXPANSION PROJECT

A speed limit reduction to 60 mph will be implemented on sections of Interstate 39/90 from just south of the US 12/18 (Beltline) interchange near Madison to the Wisconsin-Illinois border. One portion of I-39/90 between the Rock River bridges and the US 51 interchange (Stoughton Exit 156) will remain at 70 mph since construction is completed in that area. Two lanes of Interstate traffic are maintained in each direction during daytime hours and weekends.

Motorists are advised to obey the posted speed limit. The Wisconsin State Patrol will increase surveillance efforts along this corridor. This will include additional troopers patrolling the corridor and conducting aerial enforcement to enforce speed limits and other traffic laws.

Work zone safety is one of the Wisconsin DOT's top priorities and the penalties for careless driving are steep.

#### 4. PUBLIC HEARINGS

- a. Consideration of Ordinance No. 3642 amending the Zoning District map of the City of Beloit for the properties located at 836 and 842 Park Avenue. Plan Commission recommendation for approval 6-0. First reading, suspend the rules for second reading. Beloit College would like to sell these properties and they must be rezoned back to R-1B, Single-Family Residential because the properties are no longer used as student housing. The City was aware of the College's plan to sell these properties and updated the Future Land Use Map during the Comprehensive Plan update in Fall of 2018 to reflect the request. The College's request is consistent with the Future Land Use Map.
- b. Public hearing to solicit input on the community development, housing, and homeless needs in the City of Beloit for inclusion in the 2020-2024 Consolidated Plan. Any needs identified will be incorporated into the Consolidated and NRSA Plans, and will be considered when setting and prioritizing goals, along with other needs identified by the Steering Committee, stakeholder meetings, and neighborhood listening sessions.

#### 6. CONSENT AGENDA

All items listed under the Consent Agenda are considered routine and will be enacted by one motion. There will be no separate discussion of these items unless a Council member so requests, in which event the item will be removed from the General Order of Business and considered at this point on the agenda.

- a. Consider approval of regular minutes of March 4 and March 18, 2019.
- b. Referral to Plan Commission: Request to install signs in the public right-of-way identifying the Walter R. Knight bridge. On November 5, 2018, the Beloit City Council adopted Resolution 2018-187 designating the Portland Avenue bridge as the Walter R. Knight Honorary Bridge. This request relates to the installation of one sign and two markers identifying the bridge as such. The proposed sign is a ground-mounted sign with white lettering against a dark green background. The proposed sign location is a grassy area on the east side approach to the bridge, just north of the public sidewalk leading to the bridge. The proposed markers will be mounted upon boulders that will be placed at the western end of the bridge. The proposed sign and markers were selected by Public Works staff in consultation with the Knight family, and have been approved by the Park, Recreation and Conservation Advisory Commission. This request related specifically to the location and design of these identifying items.
- c. Referral to ABLCC: Application for a new Class "B" Beer and "Class B" Intoxicating Liquor License for Lexx Group LLC, d/b/a Gameland, located at 530 E. Grand Avenue, Alexander Valadez, Owner/Agent. The applicant and owner of the property have negotiated and agreement to operate the business at that location. The applicant runs House of Lexx Tattoo and Piercings at 524 E. Grand Avenue and has indicated a desire to have an adult video arcade at the property at 530 E. Grand and believes that the businesses will compliment each other. The ABLCC will review the application to

assure conformity with existing rules, regulations and zoning ordinances of the city and state and will make a recommendation to the Council based on their review. The existing license for that premise, DBA Royalty Lounge, has been surrendered to the City of Beloit with this application. The City Council will take action on the recommendation of the ABLCC at their April 15, 2019 regular meeting.

- d. Referral to ABLCC: Application for a new Class "B" Beer and "Class B" Intoxicating Liquor License for Elliott Public House Holdings, LLC, d/b/a Pig Iron Pub and Grub, located at 614 Broad Street, David A. Elliott, Owner/Agent. The location was formerly known as Mike's Roadhouse. Cupcake Investments LLC, d/b/a Mike's Roadhouse, Michael J. Fink has agreed to relinquish the alcohol license once approved by the City Council. The ABLCC will review the application to assure conformity with existing rules, regulations and zoning ordinances of the city and state and will make a recommendation to the Council based on their review. The City Council will take action on the recommendation of the ABLCC at their April 15, 2019 regular meeting.
- e. Referral to ABLCC: Application for a new Class "B" Beer and Reserve "Class B" Intoxicating Liquor License for Fresco La Casa De La Fajitas LLC, d/b/a Fresco Fajita House, located at 315 State Street, Jennifer Dominguez, Agent. Fresco Fajita House currently has a Class "B" Beer and "Class C" wine license. They are now applying for a Class "B" Beer and Reserve "Class B" Intoxicating Liquor License for the license period ending June 30, 2019. The ABLCC will review the application to assure conformity with existing rules, regulations and zoning ordinances of the city and state and will make a recommendation to the Council based on their review. The City Council will take action on the recommendation of the ABLCC at their April 15, 2019 regular meeting.
- f. Referral to ABLCC: Application for a new Class "B" Beer and Reserve "Class B" Intoxicating Liquor License for Diehl Enterprise, LLC, d/b/a Coach's Bar & Grill, located at 2745 Prairie Avenue, Derek Diehl, Owner/Agent. This is the site of the former Pitchers Mound property, which has been vacant since June 30, 2016. The ABLCC will review the application to assure conformity with existing rules, regulations and zoning ordinances of the city and state and will make a recommendation to the Council based on their review. The City Council will take action on the recommendation of the ABLCC at their April 15, 2019 regular meeting.
- g. Consideration of Resolution 2019-038 approving a cooperative agreement with Walworth County Housing Authority for Housing Quality Inspection Services. The Walworth County Housing Authority (WCHA) manages assisted housing projects in Walworth County which are required to be inspected annually. The Department of Housing and Urban Development does not allow public housing agencies participating in certain programs to inspect the units that they manage. Therefore, the WCHA must contract with another entity to provide the inspection services.
- h. Consideration of Resolution 2019-039 approving a lease agreement between the City of Beloit and Beloit Professional Baseball Association, Inc. The Beloit Professional Baseball Association has been leasing Pohlman Field in Telfer Park from the City of Beloit for as long as their Minor League Affiliate team has been in existence (1981). Staff recommends approval of the agreement.

#### 8. ORDINANCES

- a. Consideration of Ordinance No. 3641 amending the Zoning District Map of the City of Beloit for property located at 1014 W. Froebel Drive from temporary R-1A, Single Family Residential District, to permanent R-1A, Single Family Residential District. Plan Commission recommendation for approval 6-0. Second reading. The subject property is privately owned and was annexed/attached in order to connect the existing single-family home with a failing septic system to the City's sanitary sewer.
- b. Consideration of an Ordinance No. 3644 amending the Zoning District Map for the properties located at 1003, 1017, and 1021 Fourth Street and 117 Merrill Street from C-3, Community Commercial District to PUD, Planned Unit Development District and the property located at 1016 Third Street from R-3, Low Density Multifamily Residential District to PUD. Plan Commission recommendation for approval 6-0. Second reading. The proposed PUD will allow development of an underutilized site served by existing public utilities.

Good evening,

To the residents of this great city, my fellow councilors, City Manager Lori Curtis Luther, City Attorney Elizabeth Krueger, and certainly the entire staff of the City of Beloit, I want to take a little time out to say thanks to each and every one of you for what you do each and every day.

Each year we set aside time to share the city's successes. This year is no different. I graduated from Beloit Memorial High School in 1981. During that time at each and every sporting event, we had a cheer that simply stated "We're from Beloit, couldn't be prouder, you can't hear us now so we will yell a little louder." Now, back then it was simply a standard cheer. As I reflect on this simple cheer and our city, I have come to realize it is more than a cheer; it is the Beloit way. You see, when you talk to people from this great city, they will share all of the accomplishments, changes, visions, and successes that have taken place over the years.

Just like the cheerleaders boosted the fans' enthusiasm at games, we as leaders must boost the residents to become cheerleaders for Beloit. We must combat misstatements about Beloit with facts, such as our crime rate has declined in the last two years, and we have moved to 10-hour shifts for our officers to place the most of amount of officers on duty during the times the department is facing the most amount of calls. Our fire department continues to work diligently to provide fire and emergency care for our residents. Our firefighters continue to educate our parents, youth, and businesses on fire protection and prevention initiatives. If you ask them why they do this, I am certain they will say, "our residents deserve and expect a safe community."

Beloit could be known as the City of Bridges. Why? It's hard to miss all of our bridges. We have walking bridges that connect two sides of the river to make one blended city. We have driving bridges that allow cars to cross the river, once again, connecting us all as one community. And then we have the greatest bridges of all, the men and women who work tirelessly to create personal bridges to connect us all.

We're from Beloit, couldn't be prouder, you can't hear us now so we will yell a little louder.

This is evident by the partnerships made up of residents, city councilors, city staff and the business, religious, and educational community. Every single person invested in Beloit's future helps create that bridge to make us one connected community.

A strong community and city partnership benefits everyone. Last week, city staff partnered with Community Action to host a meeting in the Merrill neighborhood to talk about the goals for the Neighborhood Revitalization Strategy Area. Thank you so much to the residents who shared their vision for the neighborhood. The city will be meeting with the Hackett neighborhood at 6 p.m. March 27 at the Beloit Historical Society. We hope that more people attend to make their voices heard.

In just over a year, the NRSA plan is off to a great start. The investments in these neighborhoods over the next few years will make our neighborhood safer for the future of all of Beloit. Hats off to Community Development Director Julie Christensen, Director of Community and Housing Services Teri Downing, and the entire Community Development team for keeping their eye on the goal.

We must continue to show the residents we are working to create a workforce that reflects our community. We have made strides in both the police and fire departments and continue work in achieving this goal in all departments. We have redefined our definition of diversity in the most inclusive fashion so city staff represents a wide variety of backgrounds and experiences to make our city stronger. We will continue to enhance our hiring practices to ensure that qualified candidates from all backgrounds are given the opportunity to work for the city of Beloit.

Our city staff, under City Manager Lori Luther's leadership and with the full support of the City Council, have expanded their external hire searches to create opportunities for men and women of all backgrounds to start a career with the City of Beloit.

Thank you to City Manager Lori Luther, City Attorney Elizabeth Krueger, Human Resources Manager Hannah Kuehne and all city staff who continue to strive toward this goal.

The city implemented its updated workman's compensation policies in spring 2017, which is helping to create a safer work environment and reduce expenses. The immediate impacts are being experienced with a nearly 60% reduction in the number of injuries from 2016 to 2018. As a result, we reduced our 2019 premium by \$180,000. Thanks to Finance and Administrative Services Director Eric Miller and Risk Manager David Niedfeldt and anyone else who assisted with this task.

Year after year, the question is asked, "Where is that casino?" This past year has brought us even closer to that possibility. We are closer now than we have ever been before, and I strongly believe we will see a casino in the very near future. But in the meantime, we're seeing strong economic growth. From 2016-2018, 943 jobs were created, 19 economic development projects were completed in the city with investments over \$185 million dollars in 2018. Economic Development Director Andrew Janke did not wait on the casino, he continued to recruit businesses to come to the city.

It's exciting to see new construction, renovations and remodels happening throughout the city. We're looking forward to seeing the following businesses and organizations complete their projects in 2019:

- Beloit College's Powerhouse project (2019 completion)
- G5 Brewing Company (spring 2019)
- Holiday Inn Express
- NorthStar Radioisotopes expansion in the Gateway
- Seal-Rite Door
- Hilton Home 2 Suites
- Additional businesses, houses, condos and apartments

"We're from Beloit couldn't be prouder, you can't hear us now so we will yell a little louder." Look around, you will see neighborhoods improving through our code enforcement and neighborhood revitalization endeavors. Street Dance, Harry's Place, Holiday Parade, BIFF, and other downtown activities continue to bring visitors to the city. We must continue to tell the Beloit story of how we pulled together during a tough time and turned the city into the showcase city it is today.

Our library is seeing thousands of digital materials checked out. Our senior population has found many opportunities to learn and build relationships at Grinnell Senior Center. Our families are enjoying our parks and programs. We have introduced new programs, and we have built new playgrounds to enhance our neighborhoods.

While this has been a particularly harsh winter, our Public Works department has found ways to fully clear our main roads during major snow events a full hour faster in the last two years as compared to 2016. While we can't escape the snow, we have many hard working public works crews who have been working long hours to keep our streets clear of snow so we can all get to work and school each day.

Thank you to Downtown Beloit Association Executive Director Shauna El-Amin, all five Department of Public Works divisions (Engineering, Operations, Parks and Recreation, Transit, and Water Resources), Beloit Public Library staff, and all clubs, organizations and departments that help maintain and enhance the quality of life in Beloit.

An important project for city operations, the installation of an extended fiber optics network, was completed to provide a more reliable phone and data connection, eliminate downtime, increase security, and provide backup redundancy. Installation of utility poles help provide faster data connections and save the city significant dollars over time. Thanks to Information Technology Director Ray Gorsline and team.

The City Council meetings are paperless thanks to the efforts of our City Clerk-Treasurer Lori Stottler, who worked with our IT team to install iPads in the forum so each councilor can quickly pull up any document for the meeting. Lori's team will soon undertake our spring election and we appreciate everyone's efforts in her office to serve all our residents.

We are seeing new ways to engage our residents through the use of social media, our website, surveys, and more. We want to hear from you, and we want you to know that your voices are heard.

From sharing snow emergency information to increased tips to the Beloit Police Department via Facebook and from providing info on events to sharing videos from the Dirty Dash, our city staff has found unique ways to have meaningful conversations about issues that matter to you.

We've also been able to share all of the great things Beloit has to offer with the stateline community, Wisconsin and Illinois, and the entire nation. Our Public Works Department went viral with their version of "Ice, Ice, Baby" (and yes, Janesville, your remakes were good but ours were better). MSNBC's Your Business featured Beloit in its Small Business Saturday episode.

Do we value diversity? Of course we do!

This year we renamed the Portland Avenue bridge after Mr. Walter Knight, a man who built bridges to connect the working class to businesses, and the U.S. Navy decided to name one of its future Littoral Combat Ships the USS Beloit as a nod to our city's historical connections to the U.S. Navy through Fairbanks Morse. We're also excited that retired Major General Marcia Anderson was chosen as the ship's sponsor. Anderson lived in Beloit as a child and still has family connections here today.

Thank you to everyone who has been a bridge from where we were to where we are going.

As we continue to move forward, I would like to issue a few challenges in a few areas where I am particularly passionate.

1. I want to look at ways to address the homeless population. I know we partner with agencies and there are even people who do not want assistance, still, we must push forward. I would like us to keep this in the forefront of our minds and conversations.

2. I want to look at ways to work with individuals who are returning to the area after being incarcerated. I want to see these individuals being connected to programs that help them become a contributing member of society instead of becoming a repeat offender.

3. I want to continue to look for ways to develop a workforce to be ready as we continue to recruit new businesses.

4. We must stay the course, as we are moving in the right direction. The City Manager and her team continue to look for ways to move the organization forward. We need to continue to support and challenge them to take the organization to the next level.

As councilors, we must continue to ask the tough questions and be prepared to make tough decisions. We must continue to partner with the School District of Beloit to promote a positive image for the city.

Let's continue to tell the world that Beloit is a great place to live, work, and play.

Thank you for allowing me to serve as president the past two years. When I accepted the positon I knew it would be a challenging and time demanding position. I appreciate your partnership and ongoing dedication to this great city.

#### Spring Yard Waste Collection Starting on Monday, April 1

March 27, 2019 - Curbside collection of yard waste will take place Monday, April 1, through Thursday, April 11, 2019. Collection will take place on your regularly scheduled solid waste collection day.

Yard waste must be placed at least 3 feet away from trash/recycling carts. Yard waste must be properly contained in a clean container, paper yard waste bag, or Back-to-Nature biodegradable yard waste bag. Containers can be no larger than 39 gallons and weigh no more than 60 pounds. Yard waste cannot be contained in plastic bags. A \$1.50 sticker must be affixed to each bag, container and/or bundle.

Stickers may be purchased at City of Beloit Treasury Division (100 State St.), City of Beloit Department of Public Works Operations and Parks Facility (2351 Springbrook Court), Grinnell Hall (631 Bluff St.), both ACE Hardware stores, and all Beloit Walgreens locations.

Other yard waste collection dates are as follows:

- May 13-16
- June 10-13
- July 15-18
- August 12-15
- September 9-12
- October 14-17

If residents are looking for other yard waste disposal options, they can take the yard waste to Complete Compost LLC, 1105 E LT Townline Road, Janesville, WI 53546. Complete Compost is open from 7 a.m. to 5 p.m. Mondays through Saturdays. Fees do apply. Contact Complete Compost at (262) 725-2500 for more information.

#### Beloit Police Officers Participating in Rock County Impaired Driving Enforcement Task Force

Feb. 14, 2019 - Officers from the Beloit Police Department will be participating in the Rock County Impaired Driving Enforcement Task Force on the following dates during February and March:

- Friday, Feb. 15
- Saturday, Feb. 16
- Friday, Feb. 22
- Saturday, Feb. 23

- Friday, March 8
- Saturday, March 9
- Friday, March 29
- Saturday, March 30

During this additional enforcement, the Beloit Police Department will have more officers on patrol to discourage people from driving while impaired. The Beloit Police Department will have zero tolerance for driving under the influence, open intoxicants, seatbelt violations and improper use of child safety restraints.

"Our goal is send the message that driving under the influence puts the lives and safety of others at risk," said Sgt. Christian Dalton. "We hope this enforcement will help reduce the number of people who choose to drive while impaired."

Driving under the influence includes the use of alcohol, illegal drugs or prescription medication. The Beloit Police Department suggests all motorists take steps to protect themselves and others:

- Ensure everyone in your vehicle is buckled up every day, every trip. Watch your speed, be patient and alert.
- If you plan to use any alcohol, drugs or prescription medication that will impair your driving, choose a sober designated driver.
- If you're feeling buzzed, you likely are over the 0.08 BAC limit and should not drive. Take public transit, a taxicab, or ask a sober friend to drive you home.
- The Wisconsin DOT offers a free <u>Drive Sober mobile app</u> that includes a blood alcohol estimator, designated driver selector, and find-a-ride feature that uses a smart phone's GPS to locate alternative transportation.
- Some taverns and restaurants have programs to provide patrons with a safe ride home. Visit <u>www.tlw.org/</u> and click on Safe Ride.
- Report impaired drivers to law enforcement by calling 911. Provide as much detail as possible on the driver, vehicle, and location.

The Rock County Impaired Driving Enforcement Task Force includes the Rock County Sheriff's Department and the Janesville, Town of Beloit, Orfordville and City of Beloit police departments. Funding for the special enforcement periods is provided via a grant from the Wisconsin Department of Transportation.
