VOLUNTEERS NEEDED

There are many vacancies on municipal advisory committees. Over 100 citizens of Beloit volunteer to serve on committees, boards and commissions in an effort to make the community an even better place to live. Vacancies exist on the following:

- **Board of Appeals** - The Board of Appeals has been created for the purpose of hearing appeals related to the Zoning Ordinance and decisions of administrative officials concerning the Zoning Ordinance. Meetings are held on the 2nd Tuesday of the month at 7:00 p.m.
- **Board of Ethics** - The Board has been created for the purpose of administering and enforcing the Code of Ethics for public officials. Meets as needed, except the annual meeting in January.
- **Board of Review** - Sets tax assessment roll and hears property valuation disputes. Meets annually in May and typically hears assessment objection cases as schedule in June. The members of the Board of Review, including alternate members, shall be compensated at the rate of \$70.00 per day or fraction thereof for attendance at meetings of the Board of Review.
- **Community Development Authority** - Plans and implements economic redevelopment and housing initiatives; oversees the operations of the public housing office. Meets on the 4th Wednesday of the month at 4:30 p.m.
- **Equal Opportunities Commission** - Created to improve the quality of life by the elimination of racism in the Beloit community, this Commission takes action, studies, analyzes, and recommends solutions with respect to the major social, economic, and cultural problems that affect people residing or working within the City. The Commission also enforces equal opportunity in housing for residents and investigates complaints alleging discriminatory practices in the provisions of fair and equal access to housing or housing accommodations. Meets on the 3rd Wednesday of each even-numbered month at 5:45 p.m.
- **Municipal Golf Committee** - Reviews the operations, maintenance and finances of the municipal golf course and makes recommendations regarding the operation of the municipal golf course. This vacancy is for a "youth representative" (shall be 17 years of age or younger on the date of appointment) and the term is a one-year term ending December 31. Meets on the 3rd Wednesday of the month from March through November at 7:00 a.m.

- **Municipal Library Board** - Sets library policies; monitors finances; employs staff. Meets on the 3rd Wednesday of each month at 4:00 p.m.
- **Park, Recreation and Conservation Advisory Commission** - Recommends action regarding parks, recreation programs, and facilities use as well as local conservation issues. This vacancy is for a “youth representative” (in this section, “youth representative” means a person under 18 years of age). The youth representative shall be appointed for a one-year term ending on September 30. Meets on the 2nd Wednesday of the month at 6:30 p.m.

I-39/90 EXPANSION PROJECT

The Wisconsin DOT tells us that I-39/90 construction is ramping up for the 2019 season between Beloit and Madison. Two traffic shifts are scheduled within the next week along the Interstate, so please plan ahead.

By April 18th, all I-39/90 traffic is anticipated to shift onto the northbound concrete pavement from East Church Road, north of the US 51 interchange to County AB near Madison. Two lanes will remain open in each direction, separated by a median barrier wall.

- a. Consideration of Resolution 2019-040 approving Parking Lot Use Agreement between the City of Beloit and United Church of Beloit. In the past 4-5 years, Grinnell Hall's membership, along with the number of patrons that utilize its facilities and programming, has grown exponentially. As a result, convenient patron parking is imperative to the overall operation and success of Grinnell Hall. Over the past 3 years, United Church of Beloit and the City have formed a partnership to assist Grinnell patrons by providing additional parking in the Church parking lot. That Agreement will expire April 15, 2019 and we are seeking approval of a parking lot use agreement between the City of Beloit and United Church of Beloit for the upcoming two years and 8 months. Both parties desire to continue this partnership.
- b. Referral to Plan Commission: Consideration of Resolution 2019-045 accepting the introduction of and referring for public hearing and proceedings a resolution regarding the vacation of a portion of the 1200 block of Fourth Street in the City of Beloit, Rock County, Wisconsin. The City has received a petition from the School District of Beloit to vacate the 1200 Block of Fourth Street (from Middle to North Street) adjacent to Beloit Memorial High School. The resolution initiates the process for the vacation of the portion of the street and refers the matter to Plan Commission for recommendation. A public hearing will be required and is tentatively scheduled for the regular meeting of the City Council on June 3, 2019.
- c. Consideration of Resolution 2019-046 approving the installation of one sign and two markers identifying the Walter R. Knight Honorary Bridge. Plan Commission recommendation for approval 5-0. The proposed sign is a ground-mounted sign with white lettering against a dark green background. The proposed sign location is a grassy area on the east side approach to the bridge, just north of the public sidewalk leading to the Portland Avenue bridge. The proposed markers will be mounted upon granite boulders that will be placed at the western end of the bridge.
- d. Consideration of Resolution 2019-048 approving a Second Amendment to the Employment Agreement for Lori S. Curtis Luther. The City Council conducted and shared with the City Manager a performance evaluation on April 8, 2019 and her performance was exceptional. The resolution and Second Amendment to the Employment Agreement is included in the City Council agenda packet.
- e. Consideration of Resolution 2019-014 Authorizing Final Payment of C18-36 Citywide Fiber Optic. This project facilitated the construction of a fiber optic communication system that linked together six city buildings. The requirements of the contract have been completed to the satisfaction of the city and final payment is recommended.

- f. Consideration of Resolution 2019-049 amending Final Resolution authorizing Utility and Roadway Improvements and Levying Special Assessments against property located at 2231 Trevino Court Lots 31-34. The City of Beloit partnered with the School District of Beloit in order to help reduce the outstanding special assessment burden at 2231 Trevino Court. Collecting on outstanding deferred special assessments will ultimately help the City gain flexibility in their special assessment revolving fund.

Consideration of Resolution 2019-042 approving a new Class "B" Beer and "Class B" Intoxicating Liquor License for Elliott Public House Holdings, LLC, d/b/a Pig Iron Pub & Grub, located at 614 Broad Street, David A. The existing license for the premises at 614 Broad Street, d/b/a Mike's Roadhouse, will be surrendered to the City of Beloit prior to issuing this license if approved.
