- a. Referral to ABLCC: Consider applications for renewal of Alcohol Beverage Licenses for license period July 1, 2019 through June 30, 2020. All licenses shall expire on June 30 of each year and a renewal process is necessary to maintain operations.
- b. Referral to ABLCC: Consider a new application for a Class "A" Beer and "Class A" Liquor License for Ohana Spirits LLC, d/b/a Ohana Spirits, located at 2648 Prairie Avenue, Nicole Fischer, Agent for license period ending June 30, 2019. Nicholas Lerma d/b/a Nico's Convenience & Liquor Store is currently completing a remodeling of the store and intends to open in May, 2019. He seeks to have Nicole Fischer take over the license and run the business as Ohana Spirits, LLC. The applicant has specifically excluded the drive-up window as part of the licensed premises on the alcohol license application.
- c. Referral to ABLCC: Consideration of an amended application to reflect a change of corporate status on a Class "B" Beer and "Class B" Liquor License for Maxine's Social, LLC, d/b/a Maxine's Social, located at 863 Fifth Street, Zachariah R. Davis, Agent. The New Pop House is making an application to change the Corporate name to Maxine's Social LLC.
- d. Referral to Plan Commission: Application for a Conditional Use Permit (CUP) to allow a limited vehicle service use in the C-2, Neighborhood Commercial District, for the property located at 2034 Liberty Avenue. In December 2018, Planning staff initiated enforcement action against the owner of 2034 Liberty Avenue after discovering an unlawful auto repair shop in the rear storage area of the building on the subject property. The business is operated by Waylon Daniel, d/b/a Daniel's Auto Detailing and Repair. If the requested CUP is approved, the applicant will be required to bring the building and site into compliance with applicable building, zoning, and fire codes.
- e. Consideration of Resolution 2019-053 authorizing Application and acceptance of a Mercy Health Foundation Grant. The Fire Department seeks to purchase a compression device to provide high quality CPR to cardiac arrest patients. The cost of the medical equipment is substantial and not available in the ambulance budget.
- f. Resolution Authorizing Final Payment for Public Works Contract C18-26, Branigan Realignment. The frontage road in front of Walmart was realigned at the intersection with Branigan and the entrance to Menards. The requirements of the contract have been completed to the satisfaction of the City and it is recommended that a final payment be made.
- g. Referral to Plan Commission: Application for a Planned Unit Development (PUD) Master Land Use Plan for the property located at 2426 Prairie Avenue. The proposed redevelopment includes utilizing the existing building for a contractor office, with additional tenant office space, mechanic shop, outdoor storage, and in the future, duplexes along the south of the property. The applicant is seeking approval of a PUD in order to combine multiple land uses on one site.

- h. Referral to Plan Commission: Application for a Zoning Map Amendment from PLI, Public Lands and Institutions, District to PUD, Planned Unit Development District for the property located at 2426 Prairie Avenue. The PUD District is a special-purpose zoning district that permits greater flexibility in land planning and design standards than conventional zoning districts.
- i. Referral to Plan Commission: Request to acquire 917 square feet of land at the southwest corner of 1224 Fourth Street for the expansion of the Middle Street right-of-way. The Engineering Division has proposed the acquisition of property owned by the School District of Beloit for right-of-way purposes at the Northeast corner of Sixth Street and Middle Street. The School District has agreed to donate the land to the City to allow the construction of a right turn lane on Middle Street at Sixth Street.
- j. Resolution 2019-057 approving the Development Agreement with Cranston Elderly, LLC on the property located at 2240 Cranston Road. The Development Agreement outlines the developer's responsibilities for constructing public infrastructure necessary to serve the development.

Krueger-Haskell Golf Course Hosting Grand Reopening Celebration

May 2, 2019 - With the completion of its clubhouse renovations, the City of Beloit is hosting a grand reopening celebration at the Krueger-Haskell Golf Course, 1611 Hackett St., in collaboration with its food/beverage operator Putterz Pub.

The grand opening begins with a ribbon cutting at 4 p.m. Thursday, May 9. After the ribbon cutting there will activities for children, including free putting lessons and face painting, until 6 p.m. Hot dogs will be free for kids ages 12 and under (limit 1 per child) from 4:30-6 p.m. Yard games will be available from 4:30-7 p.m.

The headliner for the evening, Distilled, an acoustic regional band, will provide a wide variety of music and entertainment from 6:30-9:30 p.m.

The clubhouse project started last summer with the locker rooms and restrooms being remodeled. Over the winter and spring, a brand new bar and flooring was installed, as well as the interior being repainted to lighten the inside of the building. These projects gave the clubhouse a much-needed face lift as the city looks to use the facility year-round.

This project were completed through Hendrick's CareerTek's construction academy with the support of CCI.

"We are so thankful for our partnership with Hendrick's CareerTek to transform this facility into something the entire community can enjoy throughout the year," said Laura Pigatti Williamson, public works director. 
