BELOIT CASINO UPDATE

Another significant step in the process to approve the Beloit Casino Project came today when the Bureau of Indian Affairs published a Notice of Availability of a Final Environmental Impact Statement for the Ho-Chunk Nation Fee-to-Trust and Casino Project. See attached media release for more information.

The Notice of Availability of the Final EIS is published in the Federal Register on May 31, 2019 (www.ho-chunkbeloiteis.com) and will be published in the Beloit Daily News, The Janesville Gazette and The Rockford Register Star. The BIA may issue a Record of Decision for the proposed action on or after July 1, 2019, which is 30 days after the date the EPA publishes its Notice of Availability in the Federal Register. The BIA must receive any comments on the FEIS before July 1, 2019.

CLICK-IT-OR-TICKET CAMPAIGN

PLEASANT STREET TEMPORARY CLOSURE - JUNE 3

Beloit College's pedestrian bridge is expected to be installed on June 3, which requires a portion of Pleasant Street and the pedestrian path to be closed for one day.

The installation may be delayed due to a number of factors, including weather conditions. All vehicle and pedestrian traffic will be detoured to Fourth Street and via the Portland Avenue and Broad Street bridges. The contractor will have signs and barricades warning the public of the closure and detour route.

Beloit College is renovating the old power generation station - Powerhouse - into an awardwinning student center and the pedestrian bridge is part of Beloit College's project.

As always, motorists are to proceed with caution when driving through construction zones, and be on the lookout for everchanging conditions.

4. PUBLIC HEARINGS

- a. Consideration of Resolution 2019-050 approving a petition to vacate the 1200 block of Fourth Street located between Middle Street and North Street. Plan Commission recommendation for approval 5-2. The proposed area to be vacated has been administratively closed to traffic on a trial basis since the beginning of the 2018-2019 school year. This petition would permanently close the 1200 block of Fourth Street to traffic.

This project will rehabilitate approximately 5,880 feet of sanitary and storm sewer in multiple locations throughout the City of Beloit using Cured In Place Pipe (CIPP) technology. Four bids were received with the low bid of \$200,700 coming from Terra Engineering and Construction Corp.

The School District of Beloit has since requested vacation of this same segment of Fourth Street and is working with the City to provide land for the construction of turn lanes at Sixth Street and Middle/ North Streets by the City of Beloit. The purpose of this agreement is to set forth roles and responsibilities of both entities related to the vacation of Fourth Street in front of Beloit Memorial High School and the conveyance of land to the City for the turn lanes at the intersection of Sixth Street and Middle Street.

Beloit Casino Scores New Milestone in Approval Process

(Black River Falls, WI) The Bureau of Indian Affairs has published a Notice of Availability of a Final Environmental Impact Statement (FEIS) for the Ho-Chunk Nation Fee-to-Trust and Casino Project. This is another significant step in the process which ultimately will allow for one of the most significant entertainment developments and job creators in the Stateline Region.

"We've been working with our partners on getting this project off the ground. This is just another step in the whole process, but it's building a great amount of excitement. We'll be pleased to see the impact that the Ho-Chunk Nation can have on the unemployment in the Beloit area and beyond," said Ho-Chunk Nation President Wilfrid Cleveland.

"The City of Beloit is thrilled to see this process move forward. We are committed to our partnership with the Ho-Chunk Nation and are ready to hit the ground running," said City Manager Lori Curtis Luther. "The hard-working families of Beloit deserve the livable wages and quality benefits this development will bring to our community. This game-changing project significantly and positively impacts the City's ability to provide high-quality services for all residents and taxpayers.

"Individuals and families from across the country will visit this entertainment destination and experience the beauty and diversity of our community firsthand. We can't wait to show the rest of Wisconsin and the United States how we are Beloit Proud."

This FEIS publication kicks off a public comment period prior to the Bureau's recording of decision, followed by Governor Evers' concurrence.

Beloit Police Department to Participate in *Click It or Ticket* Campaign

May 23, 2019 - The City of Beloit Police Department announces its participation in the *Click It or Ticket* seat belt campaign, which will take place through June 2, 2019.

According to NHTSA, in 2017, there were 10,076 unbuckled passenger vehicle occupants killed in crashes in the United States. In that same year, 55 percent of passenger vehicle occupants killed at night (6 p.m.-5:59 a.m.) were not wearing their seat belts. Participating law enforcement agencies will be taking a no-excuses approach to seat belt law enforcement, writing citations day and night. In the City of Beloit, the maximum penalty for a seat belt violation is \$10 for adults and \$98.80 for a child restraint violation. The Wisconsin state fine for a child restraint violation is \$175.30.

"The *Click It or Ticket* campaign is so important because it raises awareness about seat belt safety during the time period when seat belts are least used," said Sgt. Christian Dalton. "With an increased number of cars flooding the streets due to the Memorial Day holiday, it's imperative we get the word out about the importance of seat belt safety."

Almost twice as many males were killed in crashes as compared to females, with lower belt use rates, too. Of the males killed in crashes in 2017, more than half (51%) were unrestrained. For females killed in crashes, 39 percent were not buckled up.

"If the enforcement crackdown wakes people up to the dangers of unrestrained driving, we'll consider our mission to be a success," said Dalton. "If you know a friend or a family member who does not buckle up when they drive, please ask them to consider changing their habits. Help us spread this lifesaving message before one more friend or family member is killed as a result of this senseless inaction. Seat belts save lives, and everyone—front seat and back, child and adult—needs to remember to buckle up—every trip, every time."

Krueger Pool Opens June 8 New Pool Safety Measures and Enhancements in 2019

May 30, 2019 - The Parks & Recreation Division and Krueger Pool staff have been busy getting ready for summer. The Krueger Pool is announcing the following updates to operations at the pool:

- Bag Checks: We are implementing a bag and cooler check policy this year as an extra safety measure. Glass and sharp objects amongst other items are prohibited from the pool area for the safety of all our guests. If you have glass bottles or other sharp objects, you will be asked to return those items to your vehicle prior to being admitted to the pool. A complete listing of prohibited items can be found on www.beloitrecreation.com.
- **Supervision:** Children under age 12 must have a parent or responsible custodian with them at all times. The custodian must be age 16 or above.
- **Life Jackets:** Please leave the water wings and floaties at home. We recognize that not everyone is a strong swimmer, so we have U.S. Coast Guard-approved <u>floatation</u> devices available while visiting the pool. If you want to bring your own life jacket vest, it must be a U.S. Coast Guard-approved device.
- Expanded concessions: Craving something a little more substantial for an afternoon snack? We have expanded our concessions offerings to include freshly hot buttered popcorn and hot dogs.
- **Credit Cards:** There is no need to dig to the bottom of your bag for that last quarter. We now accept credit and debit cards to pay for daily admission fees and concessions items.
- Code of Conduct: We want all of our guests to have an enjoyable time while enjoying our city facilities and respectfully ask pool guests to review and adhere to our code of conduct. The code of conduct will be posted at the entrance.
- **New Shade Structures:** We are installing a new shade structure so you can get out of the sun if needed, near the pool area. We are adding concrete picnic tables with umbrellas near the concessions area to provide additional shade.
- Maintenance: The pool will be repainted before it opens to extend its life and a new bathhouse roof will be installed this fall.

The pool season is June 8 through August 25 (weather permitting). Open swim is from 12-5:30 p.m. Mondays through Fridays and from 12-6 p.m. Saturdays, Sundays and Holidays. Family swim will be held in June and July from 6:30-8 p.m. Mondays through Fridays. Admission fees and season pass information is available on www.beloitrecreation.com. Season passes and REC Cards can be purchased at the Beloit Parks & Recreation Office.

Swimming lessons will be held for seven weeks from June 17-August 9. Registration and payment is required the Friday before each session at the Parks & Recreation Office, 2351 Springbrook Court or by credit card over the phone at 608-364-2890. Hours are from 7 a.m. to 4 p.m. Mondays through Fridays.

City of Beloit Fire Department Urges Safety While Grilling Out

May 29, 2019 - It's barbecue season! Whether you're looking for the perfect brat or marinated chicken, we want to see all of Beloit stay safe while grilling out.

The City of Beloit ordinance allows for cooking in grills and other similar appliances as long as it's done between 7 a.m. and 10 p.m., for no longer than four hours, and with cooking fuel such as wood (not brush, twigs or tree branches less than four inches in diameter, green tree branches, or wet, treated or painted wood, charcoal, gas or electricity). If you're grilling out or using an outdoor cooking fire at a multi-family dwelling, such as an apartment complex, you cannot grill on a balcony or underneath a balcony, according to the fire code. The grill or cooking fire must be attended to at all times by a responsible, competent individual and an extinguishing agent, such as a hose, should be nearby in case of a fire.

If you're thinking about grilling up burgers and brats, check out these grilling safety tips from the National Fire Prevention Association before you fire up the grill:

- Propane and charcoal BBQ grills should only be used outdoors.
- The grill should be placed well away from the home, deck railings and out from under eaves and overhanging branches.
- Keep children and pets at least three feet away from the grill area.
- Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill.
- Never leave your grill unattended.
- Always make sure your gas grill lid is open before lighting it.
- Charcoal Grills: Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel.
- Charcoal Grills: If you use a starter fluid, use only charcoal starter fluid. Never add charcoal fluid or any other flammable liquids to the fire.
- Charcoal Grills: Keep charcoal fluid out of the reach of children and away from heat sources.
- Charcoal Grills: There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord for outdoor use.
- Charcoal Grills: When you are finished grilling, let the coals completely cool before disposing in a metal container.
- Propane Grills: Check the gas tank hose for leaks before using it for the first time each year. Apply a light soap and water solution to the hose. A propane leak will release bubbles.

- Propane Grills: If your grill has a gas leak, by smell or the soapy bubble test, and there is no flame, turn off both the gas tank and the grill. If the leak stops, get the grill serviced by a professional before using it again. If the leak does not stop, call the fire department.
- Propane Grills: If you smell gas while cooking, immediately get away from the grill and call the fire department. Do not move the grill. If the flame goes out, turn the grill and gas off and wait at least 5 minutes before re-lighting it.
