4. Matt Febus -756 Bluff Street Certificate of Appropriateness

A. COA-2019-02 Review and consideration to approve a Certificate of Appropriateness for replacement of windows at 756 Bluff Street.

Ms. Rottmann read the staff report aloud. Discussion was had over installing new verses repairing and replacing the windows. The applicant came forward and stated that he would be open to reglazing and repairing windows instead of replacing the windows. The commission was pleased to hear this and stated that repairing the windows will be a better return on your investment and be appreciated by a future historical home owner. Commissioner Gallagher suggested a contractor that could help Mr. Febus with the project. Commissioner Blazer moved to amend the Certificate of Appropriateness to reglaze window glass, repair window frames and sashes, and if needed to replace windows with like materials.
