#### **BELOIT REPORT**

Due to staffing schedules, the Beloit Report will take a two-week break, returning on August 2nd. There will be no Beloit Report on July 19 or 26. Public notices for meetings will continue to be posted on the City's website and the City's Facebook page.

#### ANNUAL FIRE HYDRANT FLUSHING

The City of Beloit Water Resources Division will perform their annual fire hydrant flushing program from July 22, 2019 through November 30, 2019 during the hours of 7:30 a.m. to 6:00 p.m., Monday through Friday.

This flushing program ensures that the fire hydrants are in good working condition in case of emergencies and helps flush sediment out of the distribution system.

You may experience discolored water, low water pressure or a disruption of service during this time period. Residents are urged to reduce water use and consumption during this time period and wait to do laundry until <u>AFTER</u> 6:00 p.m. during the flush program.

During evening hours residents should open their cold water faucets until the water runs clear before using it.

#### 2018 FINANCIAL REPORTS NOW AVAILABLE

The City of Beloit released the Comprehensive Annual Financial Report (CAFR) and its Popular Annual Financial Report (PAFR) for the fiscal year ended on December 31, 2018, to the public.

Wisconsin State Statutes, the Wisconsin Administrative Code, and the Municipal Code of the City of Beloit require that, at the end of the fiscal year, a full and complete examination of all books and accounts of the City be made by a certified public accountant and that the report be filed with the City Clerk/Treasurer as a matter of public record. #### 2019 MONTHLY CURBSIDE COLLECTION OF YARD WASTE

In July, curbside collection of yard waste will take place from July 15 - 18 on your regular trash day.

- Yard waste consists of leaves, grass clippings, garden debris, brush and shrubbery (no larger than 4 feet long and/or 4 inches in diameter).
- All brush and shrubbery must be bundled, tied or contained with a \$1.50 yard waste sticker placed on it.
- Stickers are sold 5 to a sheet for \$7.50 and are available at Walgreens, ACE Hardware, Public Works Operations Facility, City Hall Treasury, and Grinnell Hall.
- Use only paper yard waste bags, Back-to-Nature Biodegradable bags or clean trash containers 39 gallons or less.
- Plastic bags cannot be used for yard waste.
- Yard waste containers must weigh no more than 60 pounds.
- Yard waste must be clean and litter free.
- Place yard waste at least 3 feet away from your regular trash.

The CDA recommends that setting priorities for funding will ensure allocation to projects which will meet the greatest needs for the dollars spent. It is recommended that the funding be spent on:
  - Public Service Programs that provide comprehensive case management services, with priority given to supportive housing programs, resource navigation, advocacy, education in life skills, job training, transportation, and activities which meet one of the NRSA objectives.

L. Smith to Nathan A. Brault for period ending June 30, 2020. ABLCC recommendation for approval 4-0.
- b. Consideration of Resolution 2019-089 approving the Final Plat for the Oaks, No. 2. R.H. Batterman & Co., Inc. has submitted the Final Plat of The Oaks, Plat 2 for the 19-acre property located at 2750 Rachel Terrace. The applicant has proposed the construction of a second phase of The Oaks subdivision consisting of 21 new single-family lots, an out-lot for storm water detention, and an unbuildable lot to be subdivided in the future. The subject property is already zoned R-1A, Single-Family Residential.
- c. Resolution Awarding Public Works Contract C18-12 City Hall Window Replacement. This project will result in the replacement of the stacked windows and metal siding on the south face of City Hall. The window and siding system is beyond its intended life span, and has been the historical source of leaks into the building including the IT main server room. Two bids were received for this project, with the low bid coming from Klobucar Construction Co., Inc. The Engineering Division recommends awarding this contract to Klobucar Construction Co., Inc.
- d. Consideration of Resolution 2019-101 approving a Development Agreement between the City of Beloit and American

Builders and Contractors Supply Co., Inc. ABC Supply Co. is in the process of constructing a new four-story office building on the property located at 3 ABC Drive. The City Council approved a Conditional Use Permit (CUP) for this project in 2018, and a Certified Survey Map (CSM) was approved by the Plan Commission in May, 2019. This project necessitates public improvements, and the Development Agreement outlines the applicant's responsibilities with respect to abandoning, relocating, extending, and/or constructing public facilities and infrastructure as necessary to accommodate this project. The public improvements include sanitary and storm sewers, a water main, sidewalk, and traffic improvements recommended by a Traffic Impact Analysis (TIA). As recommended by the applicant's TIA dated December 10, 2018, a new traffic signal will be installed at the intersection of White Avenue/STH 81 and Prince Hall Drive prior to final building occupancy. In addition, the northbound left turn lane on Park Avenue will be extended before the Park Avenue and White Avenue intersection as recommended by the TIA. This project will include a public sidewalk, along with improved pedestrian crossing at the new traffic signal. The proposed improvements will be constructed at the developer's cost and then dedicated to the City, unless the City's TEA Grant application is successful, in which case the City will construct the traffic improvements.

e. Consideration of Resolution 2019-092 authorizing the City Manager to submit an application for a Transportation Economic Assistance (TEA) Grant from the Wisconsin Department of Transportation. The TEA Grant may provide \$5,000 of funding for each job created and guaranteed and a 50% local funding requirement. A CIP budget amendment will be required if the grant is received. Funding will be provided by the Developer for the local match requirements.
