#### BELOIT POLICE PARTICIPATE IN 'DRIVE SOBER OR GET PULLED OVER' CAMPAIGN

The City of Beloit has joined law enforcement agencies across Wisconsin during the "Drive Sober or Get Pulled Over" campaign that began August 16th and lasts until Labor Day, September 2nd.

There are several ways citizens can help:

- Never allow someone to get behind the wheel impaired. Find a safe alternative to get them home. If you plan to celebrate, identify a sober designated driver;
- Report impaired drivers to law enforcement by calling 911. Provide as much detail as possible on the driver, vehicle, and location;
- Download the free "Drive Sober" mobile app from the <u>WisDOT</u> website. The app includes a "find a ride" feature to help locate mass transit and taxi services;

- Make sure that everyone in your vehicle is buckled up every trip. Watch your speed and eliminate distractions.

### CITY COUNCIL MEETING - TUESDAY, SEPTEMBER 3, 2019

The Beloit City Council will hold a Workshop at 6:30 p.m. in the breakroom located at the Engineering and Utilities Building, 2400 Springbrook Court. The purpose of the workshop is to review the agenda of the regular 7:00 p.m. City Council meeting. **Note the temporary location of the City Council meeting in the large conference room at 2400 Springbrook Court.** Please click <u>here</u> to view the agendas and regular Council meeting packet.

#### 6. CONSENT AGENDA

All items listed under the Consent Agenda are considered routine and will be enacted by one motion. There will be no separate discussion of these items unless a Council member so requests, in which event the item will be removed from the General Order of Business and considered at this point on the agenda.

- a. Consider approval of regular minutes of August 19, 2019.
- b. Consideration of Resolution 2019-114 adopting the 2018-2023 Parks, Outdoor Recreation and Open Space (POROS) Plan. The Parks and Recreation Division contracted with Design Perspectives to assist the Division in the development of an updated Parks, Outdoor Recreation and Open Space Plan. This plan is valid for a five year period and has been prepared in compliance with the guidelines set forth by the Wisconsin Department of Natural Resources. Adoption of this plan is required to be eligible for Wisconsin Department of Natural Resources grant funding.
- c. Consideration of Resolution 2019-115 adopting an Intergovernmental Agreement among the City of Janesville, Town of Beloit, City of Milton, City of Edgerton, City of Evansville, Village of Clinton, Village of Orfordville, and County of Rock related to an Office of Justice Assistance, Byrne Memorial Justice Assistance Grant for Crisis Intervention Training. The City of Beloit has the opportunity to apply for and participate as a sub-grantee to receive crisis intervention training for seven police officers. This is a collaborative grant process administered by Rock County. The 40-hour training program will include basic information about mental illnesses and how to recognize them; information about the local mental health system and local laws; learning first hand from consumers and family members about their experiences; verbal de-escalation training, and role plays.
- d. Referral to Plan Commission: Acquisition of a Perpetual Sidewalk Easement Over Part of 1750 Branigan Road. Planning staff recently approved site plans for the construction of an off-street parking lot on property owned by TRU Beloit Properties LLC at 1750 Branigan Road. Once constructed, the parking lot will serve as an employee parking lot serving the applicant's production facility located at 2924 Wyetta Drive. The approved parking lot site plan includes public and private sidewalks, one of which conflicts with existing fire hydrants in two locations along Branigan Road. The proposed Perpetual Sidewalk Easement will allow the proposed sidewalk to avoid the existing hydrants by veering onto the applicant's property at two locations, thereby saving the expense of hydrant relocation.
- e. Consideration of Resolution 2019-113 authorizing award of Final Payment of C18-13 Grinnell Roof Replacement. The requirements of the contract have been completed to the satisfaction of the City.
- f. Consideration of Resolution 2019-121 approving the Colley Road Cost Sharing Agreement between the Town of Turtle and the City of Beloit. Colley Road has shared ownership between the Town of Turtle and the City of Beloit. The Town of Turtle has taken the lead on the project, including the bidding and awarding processes. The City of Beloit will be responsible for the portion of the roadway within the City's corporate limits. The Town of Turtle will invoice the City after the completion of the work for it's share of the cost.
- g. Consideration of Resolution 2019-122 approving an Intergovernmental Agreement Between the School District of Beloit and the City of Beloit for the Truancy Intervention Coordinator/Juvenile First Time Offender Program Coordinator. The City of Beloit and the School District of Beloit are collaborating for the provision of an employee to work as a truancy intervention coordinator for the school district and as the Juvenile First-Time Offender Program Coordinator for the Municipal Court. The prior IGA expired and is due for renewal. The IGA provides for a one-year agreement with two automatic annual renewal periods. The maximum financial contribution is 1/4 of the employee's \$56,686 annual salary.

h. Consideration of Resolution 2019-123 approving an Intergovernmental Agreement (IGA) Between the School District of Beloit and the City of Beloit for Adult School Crossing Guards. This is a renewal of the existing IGA between the City and School District for a three-year period 2019-2022. The School District hires and supervises adult crossing guards and as a part of a prior agreement, the City supports a portion of the cost.

#### 7. LICENSES

a. Consideration of Resolution 2019-117 for approval/denial of applicants for an Alcohol Beverage Operator's (Bartender's) License for years 2019-2021.

#### 8. ORDINANCES

- a. Consideration of Ordinance No. 3658 to create Section 6.04 of the Code of General Ordinances of the City of Beloit pertaining to Fire Inspections. Second reading. The department would like to reduce the frequency of inspections and concentrate on the quality of inspection with the ability to conduct timely re-inspections with the goal being fire and life safety compliance.
- b. Consideration of Ordinance No. 3659 amending section 15.24(4) pertaining to Charges for False Burglar Alarms. Second reading. Charges for false burglar alarms are now consistent with the fee that was approved in the 2019 Resolution adopting the Master Fee Schedule with \$50 for the first offense, \$75 for the second offense, \$100 for third offense and \$125 for fourth and subsequent offense per year.
- c. Consideration of Ordinance No. 3660 to amend sections 15.06(4)(b)1 of the Code of General Ordinances of the City of Beloit Pertaining to Alcohol Sales, Consumption and Possession On/In Streets and Other Public Places Welty Center. First reading, suspend the rules for second reading. The Friends of Welty Environmental Center, Inc. is requesting to be permitted to host fundraising events at Big Hill Center using the spaces that they currently rent, as well as other rentable space at Big Hill Center. Their request requires an ordinance change since they want to be able to sell alcohol at the fundraising events. City staff is amenable to Welty's request, provided there are limitations on the sale of alcohol similar to what was approved for the Friends of the Library and Library Foundation in 2015.
- d. Consideration of Ordinance No. 3662 to create section 18.02(15)(p) of the Code of General Ordinances of the City of Beloit authorizing an annual anniversary event sponsored by Beloit Youth Hockey Association, Inc. (BYHA) First Reading, suspend the rules for second reading. In celebration of their 50th year as an association, the BYHA would like to kick off their season with food, drink, raffles, and a small car show. This event is open to the public and there is no admission charge. Event organizers would like to sell beer in a self contained area away from the rest of the event.
- e. Consideration of Ordinance No. 3663 to amend certain provisions of section 16.08 and to create section 16.085 of the Code of General Ordinances for the City of Beloit relating to smoking, tobacco products, vapor products and electronic delivery devices. First reading. The City Council has been asked to include the use of electronic delivery devices (often referred to as e-cigarettes) within its smoke-free ordinance in order to prohibit the use of such devices in the same areas covered by State law and the City's smoke-free ordinance. This proposed ordinance would prohibit the use of electronic delivery devices at the same locations in State law and City ordinance where smoking cigars, cigarettes, pipes, and other lighted smoking equipment is prohibited. The proposed ordinance further prohibits the possession and use of such devices by those under the age of 18 and prohibits furnishing such devices to minors.

#### 12. REPORTS FROM BOARDS AND CITY OFFICERS

a. Consideration of Resolution 2019-125 Approving an Amendment to the Project Plan of Tax Incremental District No. 11, City of Beloit, Wisconsin. Tax Increment District #11 was created by the City of Beloit on October 1, 2001. The City now desires to amend the project plan of the district to allow excess revenue to be transferred to Tax Increment District #9 in order to reduce an advance from the Capital Improvement Fund. TID #9 will not have sufficient increment to pay back the advance during the remaining life of the TID without the help from TID #11 and would otherwise close with a deficit balance. TID #11 has no outstanding debt and has only one active direct developer incentive. The increment exceeds any project costs and has sufficient increment to be a donor to TID #9. Both TID #11 and TID #9 will be able to close earlier than expected by allowing the sharing of increment.
