2019 TRICK OR TREAT HOURS AND HALLOWEEN SAFETY REMINDERS

City of Beloit trick or treat hours have been set for 5 p.m. to 7 p.m. on Thursday, October 31, 2019. The Beloit Police Department offers the following safety reminders:

- Wear light colored clothing, short enough to prevent tripping, and add reflectors.
- Give children flashlights and glow sticks to help them see and be seen by drivers.
- Make sure costumes are flame retardant.
- Make sure children can see well through face masks or head coverings.
- Accompany your children and go only to homes with outside lights on.
- Stay within the neighborhood and only visit homes where you know the residents.
- Walk on the sidewalk. Children should not take shortcuts through backyards or alleys.
- Only give or accept wrapped or packaged candy and treats. Examine candy before allowing children to eat it.
- Watch for traffic. Cross only at corners and never dart out between parked cars.
- Drive slowly, yield to young pedestrians, and watch out for trick or treaters darting into the street.

This notice is to inform the public that the following actions and activities will take place on the proposed allocation of \$625,000 in new 2020 CDBG funds, approximately \$116,000 in CDBG program income, and approximately \$157,700 in prior year unspent CDBG funds:

- **10-1-2019 through 10-31-2019: 30-day Public Review Period:** During the 30-day public review period, the 2020-2024 Consolidated Plan, 2020-2024 NRSA Plan, 2020 Annual Action Plan, and 2020 CDBG Budget will be available for public review and comment in the Community Development Department, Third Floor, City Hall, 100 State Street, between 8:00 AM and 5:00 PM, Monday through Friday, and at the Beloit Public Library during normal business hours. The Annual Plan and CDBG Budget will also be available on the City's website at www.beloitwi.gov under City Departments - Community Development.
- **10-21-2019 at 7:00pm at 2400 Springbrook Court, Beloit, WI:** A public hearing on the proposal will be held during the City Council meeting.

PUBLIC NOTICE

City of Beloit will submit a written exception to the federal Conflict of Interest provisions under 24 CFR 570.611. The City is requesting an exception under 570.611(d) to consider awarding 2020 and future Community Development Block Grant (CDBG) funding to the YWCA of Rock County. As part of the exception request, the City is required to publicly disclose the conflict of interest and submit to the Department of Housing and Urban Development (HUD) any comments received from the public regarding that conflict. The conflict of interest is described below, and a description of how Councilor Anderson will be withdrawn from the decision making process with respect to CDBG funding follows.

Clinton Anderson was elected to the Beloit City Council in April of 2017. The Beloit City Council annually approves the CDBG Funding Priorities, Annual Action Plan, and CDBG budget allocations. The City Council also approves the CDBG Consolidated Plan, Neighborhood Revitalization Strategy Area (NRSA) Plan, Analysis of Impediments to Fair Housing (AI), any substantial amendments, and participates in workshops related to CDBG funding. This means Clinton Anderson, as a City Councilor is both in a position to participate in the decision making process with regard to CDBG, and as the Volunteer Coordinator of the YWCA, may also have a financial interest in a contract or agreement for CDBG awarded to the YWCA of Rock County. This constitutes a prohibited conflict as defined in 24 CFR 570.611(b).

Councilor Anderson will recuse himself from any City Council meetings, workshops, or discussions regarding the CDBG funding process and will leave the meeting room while discussions and decisions are being made related to CDBG items on the City Council Agenda. Councilor Anderson will have a representative other than himself conduct presentations or provide comments regarding CDBG funding for the YWCA of Rock County during public meetings.
