### DAYLIGHT SAVINGS TIME ENDS NOVEMBER 3, 2019

As a reminder, Daylight Savings Time ends Sunday, November 3 as we “fall back” and set the clocks back an hour at 2 a.m.

The Rock County Sheriff’s Office, Wisconsin Emergency Management, and the Ready Wisconsin Campaign have provided some tips to aid in preparing for emergencies as we approach the winter season:

- Smoke Detectors: Check your smoke detector monthly and replace every 10 years.
- Carbon Monoxide Detectors: Replace detectors every five years.
- Inspect Furnaces and Wood Burning Stoves: Have a professional inspect and repair annually to ensure working order and proper ventilation. Any heating device that burns fuel produces carbon monoxide.
- Symptoms of Carbon Monoxide Poisoning: Symptoms include headaches, fatigue, dizziness, shortness of breath, nausea, and confusion. At high levels, carbon monoxide can cause death within minutes.
- Emergency Kits in the Home: Check for expired products or items that may need to be replaced. Pay attention to items such as batteries, first aid supplies, and food, which should be replaced regularly.

Candidates interested in running for a two-year Beloit City Council term may begin circulating nomination paperwork on Sunday, Dec. 1, 2019.

Beginning Friday, Nov. 1, 2019, anyone interested in running for City Council may pick up an information packet, including nomination papers. Packets are available in the office of the City Clerk-Treasurer on the second floor of City Hall during normal business hours: Monday through Friday, 8 a.m. - 5 p.m. Nomination papers and forms will also be available on the City's website <https://www.beloitwi.gov> in the [Document Center](#) in the City Council folder titled, "Information for City Council Candidates" starting on Nov. 1, 2019.

### Beloit City Council Election Info:

- There are seven members on City Council and **four** seats will be on the ballot.
- The first day to circulate nomination papers is Sunday, Dec. 1, 2019.
- A minimum of 100 valid signatures of City of Beloit residents must be submitted. Staff recommends that between 100 and 200 signatures be submitted to ensure ballot access.
- Nomination papers and all forms must be completed and filed with the City Clerk-Treasurer by 5 p.m. Tuesday, Jan. 7, 2020.
- The spring election will be held on Tuesday, April 7, 2020.
- Candidates must file required forms with the City Clerk before forming a committee and/or raising any funds.
- An informational session may be held in January for candidates who have gained ballot access.
- Newly-elected City Council members will take office on Tuesday, April 21, 2020.

"Medical Control" refers to consultation between EMS providers and a physician, typically by radio or telephone, to guide care for an individual patient or EMS incident. These physicians are required to be up to date with EMS protocols and the majority of the physicians providing this type of medical control are emergency physicians on duty in receiving emergency departments. The state requires our emergency medical services program to have a physician medical director.
- c. Referral to ABLCC: Consider a new application for a Class "B" Beer and "Class B" Liquor License for Hatley Enterprises of Beloit, Inc. d/b/a Hats Traditional Pub, located at 435 E. Grand Avenue, Gregory L. Hatley, Agent for license period ending June 30, 2020. This location was formerly known as Sud's O'Hanahans and surrendered their license to the City of June 28, 2019 after the business closed. The license is a critical piece of the business plan for this property so they are seeking the license immediately to ensure the plan can go forward.

### City to Hold Curbside Yard Waste Collection in November

**Oct. 23, 2019** - City of Beloit's Public Works Department will soon start its fall yard waste collection, including the free yard waste collection and the leaf vacuuming subscription service.

#### Free collection

The free yard waste collection will be held Nov. 4-21, 2019, on your regularly scheduled trash day.

- **Included:** Contained leaves, grass clippings and garden debris.
- **Not included:** Brush and shrubbery; leaf vacuuming.
- **How:** Use paper yard waste bags, or clean trash containers (<39 gallons and <60 pounds). Plastic bags of any type will not be collected.
- **Where:** Set yard waste 3 feet away from your regular trash on the curb.

"Please keep all leaves and grass clippings away from the street to keep them from going into storm drains, which can lead to clogged drains and harmful debris going into our waterways," said Tim Drager, Solid Waste and Safety Supervisor for the Operations Division. "When you are out raking or using a leaf blower, make sure you're directing the leaves away from the street."

#### Brush & Shrubby

Brush and shrubby will also be collected during Nov. 4-21, 2019, on your regularly scheduled trash day. Each bundle must include a \$1.50 sticker.

- **What:** All brush and shrubby should be no larger than 4' long by 4" in diameter and bundled to 4'x2'.
- **Cost:** Each bundle must include a \$1.50 sticker.
- **Where:** Set bundles 3' away from your regular trash on the curb.
- **When:** November 4-21, 2019, on your regularly scheduled trash day.
- **Stickers:** Stickers can be purchased at City of Beloit Department of Public Works (*address below*), the City Hall Treasurer's Department, (100 State St., 8am to 5pm), Grinnell Hall (631 Bluff St., 7:30am to 4pm).

#### Leaf Vacuuming Service

Don't want the hassle of putting your leaves into containers? Blow or rake the leaves into the terrace. We will take care of the rest!

- **When:** November 4-22, 2019, visit [www.beloitsolidwaste.com/leaf-vacuum-service-for-the-schedule-which-includes-various-pick-ups](http://www.beloitsolidwaste.com/leaf-vacuum-service-for-the-schedule-which-includes-various-pick-ups).
- **Cost:** (one subscription per address): \$100 for the 2019 season.

- **Sign-up:** Complete the subscription form (available at <https://beloitsolidwaste.com/leaf-vacuum-service/>). Enclose a check or money order in the amount of \$100.00 made payable to the City of Beloit and mail or sign-up in person at City of Beloit Department of Public Works Facility (*address below*).
