## 5. Review of Applicants for Vacancies with Recommendation(s) to City Council

# a. Appointment Review Committee

Incumbent **Paul Martin** stepped out while the committee discussed his reappointment. Motion by Daniel Barolsky to recommend the reappointment of Paul Martin to a term ending December 31, 2024. Pam George seconded. Motion carried unanimously and Mr. Martin returned to the meeting.

Incumbent **Dorothy Harrell** stepped out while the committee discussed her reappointment. Motion by Daniel Barolsky to recommend the reappointment of Dorothy Harrell to a term ending December 31, 2024. Paul Martin seconded. Motion carried unanimously and Ms. Harrell returned to the meeting.

Chairman Dan Gifford turned the meeting over to Vice-Chair Daniel Barolsky and left the room while the committee discussed his reappointment. Motion by Pam George to recommend the reappointment of **Dan Gifford** to a term ending December 31, 2024. Yusuf Adama seconded. Motion carried unanimously; Mr. Gifford returned to the room and resumed chairing the meeting.

# b. **Board of Ethics**

Incumbent Daniel Herro is interested and eligible for reappointment. Motion by Paul Martin to recommend the reappointment of **Daniel Herro** to a term ending December 31, 2024. Seconded by Pam George and the motion carried unanimously.

#### c. Board of Review

Incumbent Nora Gard is interested and eligible for reappointment. Motion by Paul Martin to recommend the reappointment of **Nora Gard** to a term ending December 31, 2026. Seconded by Yusuf Adama and the motion carried unanimously. The Council does not need to re-interview the incumbent.

## d. Business Improvement District (Downtown Beloit Association)

## e. Community Development Authority

Incumbent Kaylynn Rodriguez is interested and eligible for reappointment. Motion by Yusuf Adama to recommend the reappointment of **Kaylynn Rodriguez** to a term ending December 31, 2025. Seconded by Daniel Barolsky and the motion carried unanimously.

## f. Park, Recreation and Conservation Advisory Commission

As the Council representative on the PRCAC, Brittany Keyes spoke about each application, saying they were all very strong. One applicant has a family member currently serving on the PRCAC and according to the Municipal Code, "No more than one member of any family may serve on the commission at the same time." Keyes said that there is a strong presence on the PRCAC towards conservation, but expertise may be lacking in the area of youth and recreation.

Motion by Daniel Barolsky to recommend the appointment of **Robert Douglas, Jr.**, 1122 Kenwood (replacing J. Reinhard) to a term ending September 30, 2023. Yusuf Adama seconded and the motion carried unanimously.
