ADVERTISEMENT FOR BIDS**

OWNER: The City of Beloit hereby gives notice that sealed bids will be received in the office of the Director of Water Resources, Utilities and Engineering Facility, 2400 Springbrook Court, Beloit, Wisconsin 53511 for furnishing labor, materials, tools, and equipment necessary for 2020 Water Resources Chemicals. The work for which bids are asked includes the following:
APPROXIMATELY: 500,000 pounds Ferric Sulfate 60%, 17,250 pounds Chlorine Gas and 75,000 pounds Hydrofluosilicic Acid 23%.

TIME: Sealed bids will be received until **2:00 PM Local Time on the 15th day of December, 2022.** After the official bid closing time, the bids will be publically opened and read aloud.

BIDS: All Bids shall be addressed to the Director of Water Resources and shall be enclosed in a SEALED ENVELOPE, marked with the name and address of the Bidder and marked “**2023 Water Resources Chemical Bid**”. All bidders shall bid in accordance with, and shall bid upon the bid forms included in the Contract Documents. Address all bids as follows:

INSTRUCTIONS

- Bidders may submit a bid for any and/or all items listed.
- Bidders will state the chemical cost in the appropriate column. This is the cost of the chemical on a per pound basis. Unit price shall include delivery fee.
- The anticipated total price shall be the price charged per pound multiplied by the anticipated quantity.
- All chemicals shall comply with the most current AWWA specifications
- An appropriate Material Safety Data Sheet and product specification sheet will be included for each chemical bid submitted. A cover letter must also accompany the bid defining order lead-time requirements.
- All chemicals shall be delivered on an “on demand” basis. Reasonable lead-time not to exceed 5 business days. All empty totes shall be picked up by the vendor at their cost at the time of each delivery. No deposit fees for drums, totes or cylinders shall be charged.
- All bids shall be in writing to: Josh Shere, Director of Water Resources, 2400 Springbrook Court, Beloit, Wisconsin, 53511 in a **sealed envelope plainly marked “2023 WATER RESOURCES CHEMICAL BID”** by 2:00 p.m. on December 15, 2022.
- After bids are opened, no bids can be withdrawn for a period of sixty (60) days after the scheduled time of closing bids, without consent of the City of Beloit.
- Bids for items #2 Chlorine Gas and #3 Hydrofluosilicic Acid may be combined and awarded to the vendor offering the lowest combined price.
- Bid prices from the vendor/s awarded the contracts shall guarantee the bid prices for January 1, 2023 – December 31, 2023.
- Contractor and City will enter into the attached contract.

Bid review shall begin after the bids are opened. Successful bidders will be determined on the basis of overall cost, responsiveness to an order placed and relative purity of material furnished.

GENERAL INFORMATION

The following information is being provided to assist you in your bid preparation.

Item #1 Ferric Sulfate, 60%

This solution will be purchased in bulk for sidestream struvite control at the Water Pollution Control Facility. Approximately 12 tank loads a year will be used. For purposes of this bid a tanker is considered to contain 3,500 gallons with a total annual delivery of 500,000 pounds.

Item #2 Chlorine gas

This item will be purchased for chlorination of the drinking water system for the City of Beloit. Approximately ninety (115) 150 pound cylinders for a total of 17,250 pounds will be required.

Item #3 Hydrofluosilicic acid, 23%

This solution will be purchased for fluoridation of the drinking water system for the City of Beloit. Approximately 250 thirty (30) gallon drums for a total of 75,000 pounds will be used.
