### 1. Roll Call

Chairperson Beckman called the meeting to order at 7:00PM.
Commissioners Blazer, Ruffini, Carter, McDaniel, and Councilor Blakeley were present.

## 2. Nominations and Election of Officers

# A. Nomination and election of Chair Person

Commissioner Beckman declined to accept another term as Chairperson but nominated Commissioner Ruffini, Ruffini accepted. Commissioner Beckman moved to approve Commissioner Ruffini as Chairperson. Ms. Rottmann read the staff report and recommendations. The applicant, Martin Cepeda, had no additional comments to add. Commissioner Ruffini asked Ms. Rottmann if all the current exterior projects had a COA. Ms. Rottmann confirmed that the applicant would have a COA for all the current projects.
