#### 1. Roll Call

Chairperson Ruffini called the meeting to order at 7:01PM.

#### A. Robert Oehler -Certificate of Appropriateness

COA-2022-12 Review and consideration of a Certificate of Appropriateness (COA) to replace the front porch at the institutional structure located at 631 College Street.

Chairperson Ruffini asks about the roof of the porch, Mr. Oehler clarified that the roof was not being touched that only the columns and stairs would be replaced.
