- a. Promotions Obershaw reported the following . . .
 - i. Winter Crafter & Farmers' Market Average attendance 129. Dec 3rd 104. December 10th 106. Anne is heading up this event going forward. Anne will be gone January 7-14th. Julia and Shauna will be covering while Anne is gone. We are full with Vendors 17 up front and 5 in the conference room.
 - ii. **Grand Lighted Holiday Parade Recap** Overall event went well. Just need to work on improving the flow of the parade floats. Part of the issue is the interviewing of each float. It tends to cause bottlenecks. So improvement for next year is to only interview the walkers not the float participants themselves. Public work trucks did well set up as barricades. They were decorated with wreaths but next year they will light the trucks as well. Floats looked great. We had Santa, Mrs. Claus and the Grinch. There was a little hiccup with the lights in the plaza but they all came on the second time.
 - iii. Holidazzle Recap 32 locations. 38 paying vendors. We had 2 no shows at our DBA building for vendors. Most locations were really packed. Great traffic throughout the event. Feedback from attendees and businesses was positive. We had baskets and so did Sky Carp and Nest Egg. Bagels & More gave a gift card. Some saw decent sales but we are still not back to 2019 numbers.
 - iv. **DBA Annual Dinner (February 2)** This will be the DBA's 35th anniversary. Thinking of a history theme. Celebrate our location and history of Beloit. The stone for 35 year anniversary is Emerald. "Going back in time with the DBA. Celebrating the past and the present."
