- ii. Business Updates Open properties behind Beloit Daily News, Pig Iron Pub Grub, the BMO building and Cozy Bin old building. Autumn Moon is rented by Absolutely Alluring and Fresco Fajita House may be rented. Domenico's will re-open as Greenfire Wisconsin.
- iii. Business Spotlight Shauna was only given about 20 businesses so she is working on the rest and has been going well. We will get to all businesses by the end of the year.
- iv. After Hours Spotlight 5BAR had about 20 attendees. Always & Forever is scheduled for August 8.

- i. Façade & Sign Grants La La's and Absolutely Alluring's building owner will be doing some work on the façade. Approval for \$1000 each.
- ii. City Applications BMO is rebranding and removing Harris from their name, so they will be updating signs.
