#### OFFICIAL NOTICE ADVERTISEMENT FOR BIDS

**OWNER:** The City of Beloit hereby gives notice that sealed bids will be received in the office of the City Engineer, Utilities and Engineering Facility, 2400 Springbrook Court, Beloit, Wisconsin 53511 for furnishing materials necessary for 2023 Street Lighting. The work for which bids are asked includes the following:

APPROXIMATELY: 23 Sternberg Complete Lighting Assemblies, 68 Stenberg Lighting Fixtures, 10 Sternberg Decorative Base Shells, 1 Cooper Fixture on 1 Sternberg Pole Lighting Assembly, 5 Holophane Complete Lighting Assemblies, 3 Holophane Glass Globes, 2 Lumec Complete Lighting Assemblies, 1 Lumec Pole, and 1 Lumec LBC2 Decorative Base.

TIME: Sealed bids will be received until 10:00 AM Local Time on the 26<sup>th</sup> day of September, 2023. After the official bid closing time, the bids will be publically opened and read aloud.

## INSTRUCTIONS

- Bidders may submit a bid for any and/or all items listed.
- The City may award one vendor all line items in the bid or may award multiple contracts to various vendors based on the best possible combination for the City.
- Bidders will state the item cost in the appropriate column. This is the cost of the item on a per unit basis.
- Unit prices shall <u>not</u> include delivery fees. Each vendor shall submit an additional sheet clearly defining delivery fees that will be charged based on the amount of inventory ordered. The City will take these delivery fees into consideration when awarding contract(s) that are in the best interest of the City.
- The anticipated total price shall be the price charged per item multiplied by the anticipated quantity. The quantities listed are the quantities expected to be awarded. Minor variations in quantities may be made prior to award at the City's discretion.
- All bids shall be in writing to: Scot Prindiville, City Engineer, 2400 Springbrook Court, Beloit, Wisconsin, 53511 in a <u>sealed envelope plainly marked "2023 Street Lighting Bid"</u> by 10:00 a.m. on September 26, 2023
- After bids are opened, no bids can be withdrawn for a period of sixty (60) days after the scheduled time of closing bids, without consent of the City of Beloit.
- Bid prices from the vendor/s awarded the contracts may be used for future smaller orders by mutual agreement of the parties.
- After contract award, vendor will be responsible for submitting specification sheets for all materials to the City for review.

Bid review shall begin after the bids are opened. Successful bidders will be determined on the basis of overall cost.
