### 1. Roll Call

#### A. Donna Oliver-Certificate of Appropriateness

COA-2023-22 Review and consideration of a Certificate of Appropriateness (COA) to replace windows at the residential property located at 831 Park Avenue.

Ms. Rottmann read the staff report and recommendations. The applicant was not present. Chairperson Ruffini asked about the applicant's submittal. Commissioner McDaniel moved to approve the Certificate of Appropriateness subject to the conditions recommended by staff. Commissioner Carlson seconded the motion. The motion passed, voice vote. Ms. Rottmann asked the commission to seek out representatives to fill the commissions openings. Council Blakeley suggested reducing the number of members by an ordinance amendment. Chairperson Ruffini stated that if we were to do that, we would remove member at large not a district representative. Ms. Rottmann would look into updating the ordinance and provide an update at the next scheduled meeting.

D. CLG Grant Application

Ms. Rottmann reached out to consultants to obtain estimates for the scope of work as required by the grant regulations. She plans to submit the application in December.

E. City of Beloit Comprehensive Plan Ms. Rottmann gave a summary of activities that had been worked on since the July meeting.

Chairperson Ruffini would like to add a presentation on the walking tours he and his team have been working on at our November meeting.
