# 4. Certificates of Appropriateness

#### A. Pete Woodkey-Certificate of Appropriateness

COA-2024-01 Review and consideration of a Certificate of Appropriateness (COA) to renovate the exterior of the residential structure 748 Wisconsin Avenue.

Ms. Rottmann read the staff report and recommendations. Mr. Woodkey clarified the new windows would of a composite material not vinyl as the staff report described. Commissioner McDaniel moved to approve the Certificate of Appropriateness subject to the conditions recommended by staff. Commissioner Langley seconded the motion. The motion passed, voice vote. (4-0)

#### B. Pete Woodkey -Certificate of Appropriateness

COA-2024-02 Review and consideration of a Certificate of Appropriateness (COA) to repair the exterior of the residential structure and detached garage located at 630 Park Avenue.

Ms. Rottmann read the staff report and recommendations. The applicant did not have any additional comment. Commissioner Langley moved to approve the Certificate of Appropriateness subject to the conditions recommended by staff. Commissioner McDaniel seconded the motion. The motion passed, voice vote. (4-0)

#### C. <u>Pete Woodkey -Certificate of Appropriateness</u>

COA-2024-03 Review and consideration of a Certificate of Appropriateness (COA) to renovate the exterior of the residential structure and detached garage at 722 Park Avenue.

Ms. Rottmann read the staff report and recommendations. Discussion was had about the staff conditions added and how modern the design was. The commission asked the applicant about the decisions to add metal roofing, second floor lighting, and type of siding chosen. Commissioner Ruffini asked questions about directional expression and how it related to the project. Ms. Rottmann stated this property had very little architectural or historical significance and has been severely altered from its original design. She had treated this application as a rebuild and did not want to encourage fabrication of a false history of features. The proposed design was not removing or loosing design elements, but making this property its own unique structure. Mr. Woodkey advocated for keeping the second-floor lighting. Clarification was provided about the window casing requirement added in the staff recommendations. Commissioner McDaniel moved to approve the Certificate of Appropriateness subject to the conditions recommended by staff. Commissioner Langley seconded the motion. The motion passed, voice vote. (4-0)

The commission thanked Mr. Woodkey and his team for the work they had been doing in the College Park Historic District.

Commissioner McDaniel seconded the motion. The motion passed, voice vote. (4-0)
