CONTINUING ITS RESURGENCE AS A GEM OF THE ROCK RIVER VALLEY

CURRENT EVENTS AND ACTIVITIES

LABOR DAY HOLIDAY

City Hall offices will be closed on Monday, September 5 in observance of the Labor Day holiday. We will resume normal business hours on Tuesday, September 6.

Garbage, recycling and yard waste collection will be delayed one day the week of September 5-10, in observance of the Labor Day holiday. The Recycling Drop-Off Center at 2351 Springbrook Court will be closed on Saturday, September 10 to accommodate equipment and staffing needs for Saturday's garbage and recycling collection.

BUDGET PREPARATION

A good part of the time this week was again devoted to preparation of the 2012 proposed budget. Follow up meetings were held with a number of the Department Directors, spending most of the day on Monday to review budget modifications submitted in response to the allocation reductions needed by all departments in order to balance the General Fund for next year's proposed budget. As usual, all of the Department Directors were responsive and realistic and presented a workable scenario for downsizing their operations. Those changes are being inputted into the budget software and by early next week we should know whether or not we have a proposed balanced General Fund budget.

We also met with the Capital Improvements Plan Committee and finalized work on the 2012 element of the plan, which is the element that will appear in the proposed 2012 budget. Some work still remains on the projections for the next five-year element, which will be included in the actual Capital Planning document.

HENRY AVENUE BRIDGE CLOSURES

Again, we want to remind the community that the [Henry Avenue Bridge](#) is scheduled to be closed on **Tuesday, September 6, 2011**, immediately following the holiday weekend.

CONSTRUCTION UPDATES

Construction on all of the projects continued this week. We were hoping to see paving begin on both Shirland and Park this week. Much of the underground and utility work related to these projects is now complete, and paving will be done in the near future.

HERITAGE DAYS WEEKEND/9-11 ANNIVERSARY COMMEMORATION

Heritage Days weekend is fast approaching, with a number of events scheduled for the weekend of September 10 and 11. September 11, this year, of course, is the tenth anniversary of the terrorist attacks against the United States on 9-11, 2001. There will be numerous activities around the community, including a request for the entire community to participate in a moment of remembrance, which will be a minute of silence observed at 12:00 p.m. Central Daylight Time. FIRST REGULAR SEPTEMBER COUNCIL MEETING HELD ON TUESDAY, SEPTEMBER 6

Due to the Labor Day holiday, the first regular City Council meeting for the month of September will be held on Tuesday, September 6, 2011. A synopsis of the various items included on that agenda are included in the Agenda Review section of this "Beloit Report."

CITY COUNCIL MEETING - TUESDAY, SEPTEMBER 6, 2011

At **6:30 p.m.** the City Council will have an [Agenda Review](#) session in the City Manager's Conference Room.

The [attached](#) agenda is for the **TUESDAY, September 6, 2011** regular City Council meeting beginning at 7:00 p.m. in the Forum.

3. SPECIAL ORDER OF THE DAY/ANNOUNCEMENTS

- a. Proclamation recognizing the National Moment of Remembrance for the **tenth anniversary of September 11, 2001**. A number of activities are scheduled for the country to commemorate the anniversary of the terrorist attack on the United States, including a moment of remembrance which will last for one minute, beginning at 12:00 p.m. Central Daylight Time at which residents and City officials will be asked to cease all other activity and to stand in remembrance. There may be other activities, including ringing bells and sounding sirens that will coordinate with the event.

4. PUBLIC HEARINGS

- a. We have one public hearing on revisions to the **Subdivision** Ordinance, which were required as a result of recent statutory changes. The ordinance was earlier referred to the Plan Commission, has been reviewed and received a unanimous recommendation for approval. The Ordinance is on the agenda for consideration to suspend the rules for second reading and adoption at this meeting.

6. CONSENT AGENDA

- a. Approval of the **Minutes** of the minutes from regular and special meetings of August 15, 2011 and the special meeting of August 22, 2011.
- b. Application for a **Class "A" Beer License** for Liberty Quick N Save that is being referred to the Alcohol Beverage License Control Committee for their review and recommendation.
- c. Resolution approving an **Intergovernmental Agreement** between the City of Beloit and Beloit Township to host a joint electronics recycling campaign. The City has participated jointly with the area town governments, making a joint application for funding to support this recycling effort each year. Once again, this resolution would authorize the Intergovernmental Agreement between the City and Town of Beloit to participate jointly in the application and the recycling campaign.
- d. This is a resolution approving an **Intergovernmental Agreement** between the City of Beloit and Turtle Township to host a joint electronics recycling campaign. This resolution would create a partnership between the City and the Town of Turtle for the same joint electronics recycling campaign.
- e. Resolution authorizing the final payment for Public Works contract **C10-18 for the Milwaukee Road sidewalk**. This work was completed earlier this season. The contract is complete and ready for final payment.
- f. Resolution awarding Public Works contract **C11-04 Sunshine Alley**. Sunshine Alley is located parallel to Prairie Avenue and is being installed to provide access to the remodeled Public Housing units located on Sunshine Drive. The City has opened bids and the project is ready to proceed to construction.

7. ORDINANCES

- a. Ordinance to **remove the two-hour parking time limit** along Copeland, Harvey, Randall and Keeler Streets between Park Avenue and Wisconsin Avenue. This request was first made by a citizen, was subsequently reviewed by the City's Engineering Division and the Traffic Review Committee. Residents in the area were contacted and most concurred with removing the parking restrictions as recommended by the Traffic Review Committee.
- b. Ordinance to **remove ten-hour parking time limits** in the downtown area. This request also originated with businesses concerned about the longer time limits. Once again, the Downtown Beloit Association and local businesses were polled, and most concurred that the longer ten-hour parking time limits can be removed. As with all of the timed parking zones in the downtown area, they were put into place primarily for the convenience of local businesses and we see no problem in removing the time limits at this time. Overnight parking will still be prohibited per the existing City Ordinance, unless there is a special permit that has been issued for that purpose.

10. CITY MANAGER'S PRESENTATION

- a. Judge Henderson will be in attendance to report to the City Council on the Municipal Court's **Juvenile First Time Offender Program**.

11. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution providing for the sale of approximately \$8.6 million in **General Obligation Refunding Bond Series 2011**. Our financial consultant, Ehlers and Associates, routinely monitors the market place and advises the City whenever it is financially advantageous to refinance any portion of the City's existing debt. We were recently notified by Ehlers that reduced interest rates have provided an opportunity to realize a significant savings by refinancing \$8.6 million of existing General Obligation Debt. Representatives from Ehlers and Associates will be in attendance at the meeting on Monday evening to make a presentation to Council regarding the potential savings of moving forward with this refinancing at this time. Again, this request would be to refinance existing debt only and does not add any new General Obligation debt.
- b. Resolution authorizing the Manager to enter into a revised State and Municipal Agreement with the Wisconsin Department of Transportation regarding the **design and construction of the Henry Avenue Bridge** project. This is actually the second revised agreement we have had with DOT regarding the Henry Avenue Bridge project this year. There are two reasons why this contract is coming forward for Council's reconsideration. First of all, the bids came in somewhat above the Engineer's estimate. Considering the size and scope of this particular project, including working in the river, DOT officials did not feel that the bids were at all out of line. Also, most of the additional cost for this project is the responsibility of the State DOT. The City's share of those increased costs is \$119,800. Once again, there were a number of bids on the project and both the DOT and the City Engineers viewed the bidding as responsive, and the bid was awarded by the DOT to the lowest responsible bidder.

Second, the DOT determined that some of the local credits that were used to fund the Riverside Drive improvement could not be applied to that project. Although originally included in the budget for Riverside Drive, those credits became ineligible when the City received a Federal enhancement grant, which was awarded fairly late in the project design process. Following construction, the DOT contacted the City and indicated that the credits would have to be used elsewhere and the City reminded DOT that the project was funded with 100% State and Federal funds, including the credits, and that there was no local match available to cover those costs. Consequently, through additional negotiations, the DOT agreed to move the credit and a small additional DOT allocation to the Henry Avenue Bridge project, rather than the Riverside Drive project. The bottom line is that the State will be able to adjust its reimbursements to meet all of the necessary funding requirements, yet the City will be spending exactly the same sum of money (\$1.9 million) on the Henry Avenue Bridge that we have utilized in planning estimates going back four plus years to when the original engineering work began for this project. In addition to that sum, a separate amount for the water main installation is available from bond proceeds remaining from the well #11 project. Funds will be included in a 2012 and 2013 capital budgets to cover the City's costs for this improvement. It should be noted that the State and Federal funds available for this project total over \$6.6 million.

- c. Resolution authorizing the City Manager to enter into a revised State and Municipal Agreement with the Wisconsin Department of Transportation regarding the design and construction of Riverside Drive. As noted in the previous resolution regarding the Henry Avenue Bridge project, the City was allowed to use credits and other State funding totaling \$476,970 for work earlier completed by the City on State marked routes as a credit toward the construction of the Riverside Drive project. As a result of the use of this credit plus various Federal and State grants and funding sources, the complete reconstruction and upgrade of

Riverside Drive was done at no cost to the City. Following completion of the project, the State discovered in their post-project review that they would not be able to use those credits on Riverside Drive because of a Federal enhancement grant, which was received for this project late in the design process. Through subsequent negotiations between the City and DOT officials, we managed to balance out that amount by applying the credits totaling \$398,470 plus small additional local roads grant totaling \$78,500 to the Henry Avenue Bridge project so that the City's cost for both projects remains exactly the same as originally budgeted. It will essentially be a wash for the City, and the DOT, with their internal accounting, will split payments from the City between the two projects.

HENRY AVENUE BRIDGE CLOSURE

Beloit, Wisconsin (September 1, 2011) – On Tuesday, September 6, the Henry Avenue Bridge will close to both vehicular and pedestrian traffic. The bridge will close for a large reconstruction project. This project will widen the bridge from two lanes to four lanes, and create a separate bicycle and pedestrian path. The project is expected to be completed in September of 2012. The project will be constructed by Zenith Tech of Waukesha, Wisconsin.

A detour will be posted; Riverside Drive to Portland Avenue to Fourth Street to Liberty Avenue to Sixth Street to Maple Avenue.

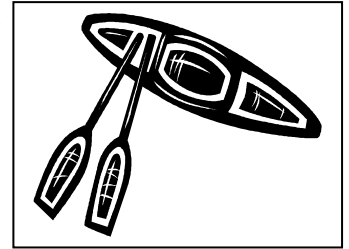

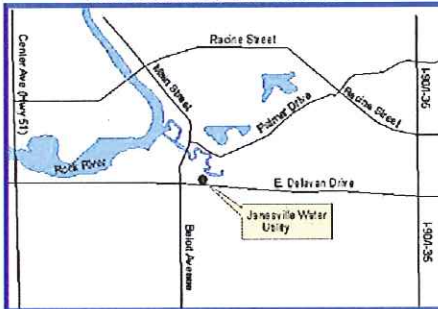

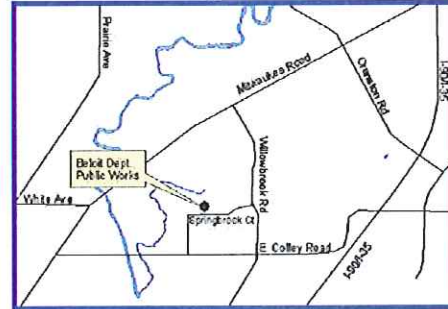
