CONTINUING ITS RESURGENCE AS A GEM OF THE ROCK RIVER VALLEY

CURRENT EVENTS AND ACTIVITIES

NATIONAL LEAGUE OF CITIES LEGISLATIVE CONFERENCE

Council President Haynes and I had a very successful trip to Washington, D.C. to participate in the National League of Cities Annual Legislative Conference. Monday and Tuesday were filled with educational sessions, mostly related to Federal services and programs for municipalities. The recent sequestration brought out a number of cabinet secretaries who attended to talk about their programs and activities, and also discuss their concerns about the sequestration program, which is beginning to impact the Federal government. The City has received some notices about possible funding reductions and programs, like Community Development Block Grant and HOME, although we have not yet received any official notifications.

We spent all day Wednesday on Capitol Hill, meeting with the Chiefs of Staff for both Wisconsin Senators, as well as Congressman Pocan. We had very productive sessions, briefing all of these key staff on issues important to the City, including making sure that Federal funding is maintained for the important I39/90 widening and reconstruction, including the I-43 interchange, the fee-to-trust application for the Beloit Casino Project, and also discussed some of the legislative issues of importance to the NLC, including comprehensive immigration reform.

We returned to the City late on Wednesday afternoon.

CITY MANAGER TO PARTICIPATE IN MAYORS FOR MEALS PROGRAM

Next Wednesday, March 20, our local Meals on Wheels Program will participate in the National Mayors for Meals initiative. As we have done for the last several years, the City Manager and other City officials will step up to help deliver meals to needy residents on that date.

WORK ON COMPENSATION PLAN CONTINUES

We have a teleconference with the consultant coming up next week, along with a number of meetings with City employees to present the plan as modified to date. We anticipate some additional changes coming out of that discussion and, out of those discussions, still hope to have a final draft plan to the City Council for their review and consideration prior to the end of March.

The Beloit Housing Authority will relocate their offices from City Hall to the Beloit Housing Authority's administration building, located at 210 Portland Avenue. The BHA will be closed for business on Thursday, March 21 and Friday, March 22 to accommodate the move and set up the new offices. Normal operations will resume at the new location on Portland Avenue at 8:00 a.m. on Monday, March 25, 2013. All contact information, including e-mail addresses, fax and telephone numbers will remain the same.

CITY COUNCIL MEETING - MONDAY, MARCH 18, 2013

On Monday, March 18th the City Council will hold a **Special Council Meeting with Closed Session** at 5:30 p.m. in the City Manager's Conference Room. We will confer with the City Attorney on a matter related to future litigation. The second item on the Closed Session pertains to a real estate transaction and possible Development Agreement. No announcements are anticipated and the Council will adjourn prior to 6:30 p.m. when the normal agenda review session will convene.

The City Council will hold a **workshop at 6:30 p.m.** in the City Manager's Conference Room, 4th Floor, on Monday, March 18, 2013 for the purpose of reviewing the agenda of the regular 7:00 p.m. City Council meeting.

4. PUBLIC HEARINGS

- a. Proposed Ordinance amending the **Comprehensive Plan** for properties located at 1500 and 1505 Gateway Boulevard from Mixed Residential use to the Business Park use designation. These properties were recently acquired by the City and it is anticipated that their use will be for a business related purpose. The Comprehensive Plan change was unanimously recommended by the Plan Commission by a vote of 6-0.
- b. Proposed Ordinance to amend various sections of the City of Beloit Municipal Code relating to the **Reorganization of the Community Development Department**. This reorganization was completed many months ago; however, it took time to review the entire Municipal Code and to identify all of the related items which were impacted by the job title changes incorporated during the reorganization process. Once again, this was unanimously recommended for approval by the Plan Commission. We also have this on the agenda for a first reading with a request to suspend the rules for a second reading and adoption.
- c. Proposed resolution approving the **Vacation** of an unnamed alley in the block bounded by North, Sixth, Olympian, and Fourth Streets. This alley lies within the property recently acquired by the School District and will be used for expansion of the facilities at the high school. Once again, the proposal was unanimously recommended by Plan Commission.
- d. Proposed Resolution approving a **Conditional Use Permit** to allow a self-service storage use in conjunction with the rental of trucks and trailers in a C-3, community Commercial District, for the property located at 3022 Ford Street, which was previously used by UBC Building Supply and, earlier, Wickes Lumber. This is an old property comprised of a number of lumber sheds and a couple of older, metal buildings. U-Haul is requesting a Conditional Use Permit to remodel the site to be used as a current U-Haul retail operation, which would include self-storage, as well as the rental of trucks and trailers and the on-site storage of RV's and other vehicles. The condition of the existing site, including the buildings and the structures located on the property, as well as the nature of the use, are certainly not in keeping with the quality of the newer development which has occurred along Milwaukee Road. The use would also be incompatible with the Milwaukee Road Overlay zoning district, which envisions more high quality commercial uses and minimal, if any, truck or trailer storage along the entrance to this important Gateway to the City of Beloit. The planned institutional buildings by both the hospital and the School District, which would be located a few blocks west of the site, further

underscore the quality of new development being undertaken throughout the Milwaukee Road corridor. For all of these reasons, the staff recommended against approval of this project. Information has been received by the City both supporting and opposing the project. The Plan Commission voted 3-2 for the development, relying heavily upon information provided by the real estate broker handling the transaction. The staff recommendation continues to be denial for this use at this location; although there is no objection to the U-Haul concept and there are several other more appropriate sites in the City where this business could domicile.

6. CONSENT AGENDA

- a. Approval of the **Minutes** of the Regular Meeting of March 4, 2013.
- b. Resolution approving a **Certified Survey Map** for the property located at 1650 Lee Lane. This is the new zoning lot that is being created for the hospital's new cancer treatment center. Plan Commission recommendation was unanimous for approval.
- c. Resolution authorizing the final payment of **Public Works Contract** for the Weiser Station. This work was completed last year and the contract is ready for closure and final payment.
- d. Resolution awarding a **Public Works Contract** for Portland Avenue Reconstruction. This project was included in the Capital Spending Plan for 2013. Plans have now been completed and bids received for award of this project.
- e. Application for a **Conditional Use Permit** to allow indoor alcohol sales and limited vehicle service uses in a C-2, Neighborhood Commercial District, for the property located at 2240 Cranston Road, for a proposed Casey's General Store to be built at this location. The matter is being referred to the Plan Commission for their review and recommendation.
- f. Application for a **Certified Survey Map** for the property located at 2240 Cranston Road, for a proposed Casey's General Store. This is needed to carve out the parcel that would be acquired and used for the Casey's General Store. This matter is being referred to the Plan Commission for their review and recommendation.

7. LICENSES

- a. This is a request by the City Clerk for Council to consider and take action on a recommendation regarding a **Class "B" Beer and "Class B" Liquor License** for Thirsty Badger Bar and Grill, located at 2983 Prairie Avenue. The license was approved by Council almost a year ago, but never issued because the business was never opened. The matter was brought before the Alcohol Beverage License Control Committee and a recommendation formulated for Council consideration. The resolution included on the agenda provides additional information about the timeline and resolution of the licensing matter.

8. ORDINANCES

- a. Second reading of a proposed Ordinance to amend the Code of General Ordinances of the City related to Alcohol in Parks to allow **Tailgating** in advance of Beloit Professional Baseball Association Games. In a meeting we held last week with representatives from the Snappers, it was decided to allow tailgating but prohibit the consumption of alcohol in the parking lots for this year. The team may use the small portion of the lot located in front of the Edwards Pavilion for various promotional or special events during that three-hour period, but once again, no alcohol would be served. On Monday, we will be recommending that Council permanently table consideration of this ordinance until such time as the team may wish to allow alcohol consumption as part of the tailgating events.
- b. Proposed Ordinance to **Remove No Parking Regulations** on Olympian Boulevard. This matter was thoroughly reviewed by the Traffic Review Committee, who unanimously recommended for approval.

9. APPOINTMENTS

Council will have recommendations from the Appointment Review Committee for appointments.

11. CITY MANAGER'S PRESENTATION

- a. The City Manager's **Report to the Community** will be presented at this Council meeting.

12. REPORTS FROM BOARD AND CITY OFFICERS

- a. Resolution authorizing the City Manager to apply for **Focus on Energy Grants** that help cover the cost for energy conservation. The staff report from populations provides far more detail about how the City proposes to build indoor wood burning furnaces in both of the major Public Works facilities (Operations and Utilities). The City has more than an adequate supply of wood available from its normal forestry operations so no additional harvesting of trees would be required to support the wood burning furnaces. In fact, we anticipate the arrival of the Emerald Ash Borer, which may create more than an adequate supply of wood in the future. As Councilors will note, the turn around time on savings for these projects is of relatively short duration, plus there is the obvious savings of being able to use all of the wood generated by City forestry operations by converting that by-product to energy. Staff recommends approval of this application, which will further expand the City's sustainability initiative.
- b. Resolution approving the School Resource Officer Program **Agreement**. Unfortunately, preparations for the revised agreement ended up in a pile last fall and the document was not completed and forwarded to Council for consideration. Some weeks ago, it was discovered that the agreement had not been finalized and the necessary modifications were completed at that time. Obviously, this is a very important program related to school security, as well as our outreach and education of young people in the community. Renew the program as currently configured.

Absentee Voting In Person for the Spring Election
Available Starting March 18, 2013

March 11, 2013 – Beloit, WI: Beginning Monday, March 18, 2013, electors registered to vote in the City of Beloit may cast an absentee ballot in person for the April 2, 2013 Spring Election. Electors who are not registered to vote and those who need to change their names and/or addresses must bring proof of residence to register. Please find the acceptable forms of proof of residence on the following page.

Late registration and absentee voting in person will be available from **Monday, March 18th through Thursday, March 28th** in the City Clerk's office on the second floor of City Hall. In celebration of the Spring Holiday, City Hall will be closed on Friday, March 29th. However, electors may still register and vote by absentee ballot on **March 29th** on the first floor of City Hall, outside The Forum. Electors who would like an absentee ballot mailed to them must make the request in writing via email to lemirer@ci.beloit.wi.us; via mail to 100 State Street, Beloit, WI 53511; or in person at the City Clerk's office.

Photo identification or other proof of identity will **not** be required to obtain an absentee ballot or to obtain a regular ballot on Election Day at the polling place for this Election.

ACCEPTABLE FORMS OF PROOF OF RESIDENCE

One of the following is required to register to vote in the Clerk's office during the closed registration period or on Election Day at the Polling Place:

- A current and valid Wisconsin driver's license
- A current and valid Wisconsin identification card
- Any other Official ID Card or license issued by a Wisconsin Governmental body
- An ID card with your photo issued by an employer during the normal course of business (not including a business card)
- A real estate tax bill or receipt (for the current year or year before the election)
- A residential lease which is effective for a period that includes Election Day
- A university, college, or technical college identification card (must include photo) together with a fee payment receipt issued to the cardholder by the university, college or technical college dated no earlier than 9 months before the date of the election at which the receipt is presented
- A utility bill for a period starting no earlier than 90 days before Election Day
- A bank statement or current pay check
- A government check or any other official document issued by a unit of government

NOTE: all of the above must contain a current and complete name, including both first and last name; and a current and complete residential address, including numbered street address, if any, and the name of the municipality. If the form has an expiration date, it must be valid on Election Day. **An individual may not register or vote without one of the above forms of proof of residence.**
