11. CITY MANAGER’S PRESENTATION

- a. 2016 (CAFR) Comprehensive Annual Financial Report presented by Eric Miller, Finance and Administrative Services Director. The CAFR is prepared by the City’s Finance Department and consists of management’s representations concerning the finances of the City of Beloit. A link to the Draft 2016 Comprehensive Annual Financial Report is available on the home page of the City’s website.

12. REPORTS FROM BOARDS AND CITY OFFICERS

- a. Resolution amending the 2017 Water Resources Division Operating Budget. An Illinois contractor paid restitution to the City in the amount of \$130,500. The funds have been received and allocated to a revenue account in the sewer utility’s wastewater treatment facility operating budget. The sewer utility requests that the 2017 sewer utility operating budget be amended to re-allocate the \$130,500 to the budget’s Contracted Services—Labor line item and be used for a clarifier upgrade at the wastewater treatment facility.
- b. Resolution approving the 2016 Wastewater Utility Wisconsin Compliance Maintenance Annual Report. The purpose of the Wisconsin Department of Natural Resources Compliance Maintenance Annual Report (CMAR) is to evaluate the wastewater treatment and collection systems for problems or deficiencies. Following the completion of the City of Beloit’s CMAR, the point system score indicates the Water Pollution Control Facility is fully compliant with all requirements. The CMAR is attached to the City Council packet for viewing.
- c. Resolution authorizing the City of Beloit to apply for the 2017 Bulletproof Vest Partnership (BVP) Grant and future BVP Grants. The BVP initiative provides funding to purchase body armor for sworn law enforcement officers. The Beloit Police Department has a mandatory body armor wear policy. The Beloit Police Department (BPD) has a five-year replacement schedule on body armor and last participated in this grant in 2012. The BPD intends to pursue the grant each calendar year to provide a 50% match funding for body armor from the U.S. Department of Justice—Office of Justice Programs.
