MINUTES TRAFFIC REVIEW COMMITTEE

November 27, 2017, 1:30 p.m. City Manager's Conference Room. 4th Floor City Hall Beloit, WI 53511

A meeting of the Traffic Review Committee of the City of Beloit, WI was held Monday, November 27, 2017 at 1:30 p.m. in the City Manager's Conference room. D. Nord called the meeting to order at approximately 1:31 p.m.

1. Roll Call

2. Approval of the minutes from the September 25, 2017 Traffic Review Committee Meeting

Minutes of the September 25, 2017 meeting were approved on a motion by T. Nee, seconded by M. Flesch

3. Public Participation

A. Janke spoke about his communication with S. Bryden regarding the need for a crosswalk cone on Broad Street.

4. Ordinance to remove the No-Parking restrictions on Freeman Parkway near the south half of the Maple Creek Apartment complex.

Staff recommendation is to keep the existing regulations in place. Mr. Hoffman discussed his desire for the residents of the Maple Creek Apartments to park along Freeman. Motion to approve staff recommendation passed unanimously on a motion by Flesch, seconded by Nord.

5. Ordinance to remove the No-Parking signs on Lee Lane and Blarney Stone Drive.

Staff recommendation is to remove the existing signs due to the change of use. Property is no longer being used as an elementary school. Motion to approve staff recommendation passed unanimously on a motion by Nord, seconded by Ramsden.

6. Ordinance to establish No-Parking zone on west side of Branigan Road between Milwaukee Road and Wyetta Drive.

Staff recommendation is to establish No-Parking on the West side of Branigan between Milwaukee and Wyetta. The ordinance is to update the Index of Special Locations, reflecting what is currently in place. Motion to approve staff recommendation passed unanimously on a motion by Ramsden, seconded by Nee.

7. Discussion related to crossing of pedestrians near BRyden Motors (548 Broad Street).

S. Bryden discussed the need for an improved crossing, preferably in front of the business door at 548 Broad Street, due to the high volume of customers crossing between lots. He stated the vehicle traffic along Broad is moving at a high rate of speed. A crosswalk will be established on the west leg of Broad Street and Prospect Street. Bryden motors will be allowed to put out an in-street cone/sign once the crosswalk is established.

8. Discussion related to cars parked along Bluff Street near Highland Avenue

Discussion took place related to the need for the removal of parking due to the sight triangles for vehicles entering onto Bluff. Item will be brought back to the committee for an action item once contact is made with the adjacent property owners.

9. Committee Member Participation

S. Blakely had concerns regarding motorcycle speeding on Gateway Boulevard. Also, had concerns regarding traffic not stopping at the stop sign near the southeast corner of the Library parking area.

10. Next Meeting

The next meeting of the Traffic Review Committee is scheduled for Monday, January 22, 2018 in the City Manager's Conference Room (4th floor of City Hall) at 1:30 pm.

Background Information:						
City of Beloit-Sign Crew is in the process of updating the signage in the neighborhood near the old McLenegan School site.						
Key Issues (maximum of 5):						
1.	McLenegan School, at the corner of Sunshine Lane and Elmwood Avenue closed permanently after the 2015 school year.					
2.	The property is currently being used as a church. The "No-Parking" and school signage has remained until it was clear that the property would not be utilized to house students.					
3.	The School speed limit and crossing signs can be removed without action, however the No-Parking signs were established by previous ordinance and will need an ordinance change before removal can occur.					
4.	The No-Parking signs related to the school are adjacent to the school property on Sunshine Lane.





Re: Request for No Parking Zone – West Side of 500 Block of Third Street

I am writing in order to request that the Traffic Review Committee (TRC) consider establishing a No Parking Zone on the west side of the 500 Block of Third Street between the driveway to the Ironworks parking lot and the stop sign at W. Grand Avenue and Third Street.

The Ironworks area of downtown Beloit has experienced tremendous reinvestment and revitalization, with the most recent project being the opening of the YMCA Ironworks facility. The vast majority of off-street parking for this facility is located in the publicly owned Ironworks Parking lot on the west side of Third Street. YMCA patrons must cross Third Street in order to reach the facility, and almost all patrons cross in the area of the driveway, which is a mid-block area. A few patrons cross near the spine roadway, while no patrons walk a half-block south to cross at the striped crosswalk at W. Grand Avenue, and then return a half-block north to reach the YMCA entrance. As shown on the attached photos, parked cars between the Ironworks parking lot driveway and the stop sign at W. Grand Avenue create a serious safety concern by blocking pedestrians from seeing oncoming northbound traffic, and by blocking northbound traffic on Third Street from seeing pedestrians crossing the street. This hazard is exacerbated by the curved roadway between the parking lot driveway and W. Grand Avenue.

The YMCA is a major destination, and there are dozens of people crossing Third Street every hour at this blind crossing location. I am not requesting a crosswalk, as this is a mid-block location where a crosswalk may not be appropriate. However, I believe that there are serious safety concerns and known risk posed by parked cars at this location, which could be reduced by restricting the parking of vehicles that prevent pedestrians and vehicles from seeing one another. This would eliminate approximately 4 legal parking stalls. Please consider establishing a No Parking Zone on the west side of the 500 Block of Third Street between the driveway to the Ironworks parking lot and the stop sign at W. Grand Avenue as shown on the attached map. As an alternative, only the "curved" 20-30' section could be established as a No Parking Zone, which would eliminate fewer parking stalls but still enhance visibility. Thank you.





Topic / Purpose for Presentation: Ordinance to remove No-Parking restrictions along the east side of Freeman Parkway near the south half of the Maple Creek Apartment complex.						
Engine	round Information: eering received direction from the City Council to reassess the parking issue along Freeman Parkway near of the Maple Creek Apartments.					
Key Is	Originally, a resident in the neighborhood had requested to extend the No-Parking along Freeman Parkway. The item was discussed during the February 2014 TRC meeting at which Mr. Hoffman, Maple Creek Apartments, opposed the extension of No-Parking and requested the existing No-Parking be removed. The Committee decided to keep the existing regulations in place. Mr. Hoffman's official request to remove the No-Parking restriction was addressed at the June 2014 TRC meeting and the Committee decided to keep the parking regulations in place with the understanding that the issue could be reviewed again once the apartments were all occupied.					
2.	Mr. Hoffman brought back the issue to the Committee at the November 2017 meeting with the reasoning that most of the units were occupied and that allowing on-street parking would be closer and more convenient for some of the rental tenants. The Committee decided to make a recommendation to keep the No-Parking restrictions in place.					
3.	The issue was brought forward for the 1 st reading at the February 19, 2018 City Council meeting. At the meeting the Council asked that the issue be brought back as an agenda item for the February 26 TRC meeting with the hope that the staff and TRC could come up with an acceptable compromise for the parking along Freeman.					
1.	A vision triangle for vehicles exiting the driveway at the Maple Creek Apartments was calculated with the assumption that the driver would pull out past the sidewalk. At most, the parking could be extended an additional 70' on the east side of the roadway (from existing sign south to sidewalk). The parking on the west side of the roadway should also be extended approximately 55' to the south (from existing sign to the driveway). Alternate overnight parking regulations would be clearer and easily enforceable.					
5.	The existing parking restrictions to the south would remain in place along Freeman Parkway.					
Staff re	Required / Recommendation / Evaluation: ecommendation is to remove No-Parking restrictions for 70' south on the east side of Freeman Parkway 's south on the west side of Freeman Parkway.
