## DAYLIGHT SAVINGS TIME - SPRING AHEAD TO PREPAREDNESS

The Rock County Sheriff's Office reminds everyone that as Daylight Savings begins this Sunday (March 11th at 2:00 a.m.) and we "spring forward," it is an ideal time to take care of routine safety maintenance in our homes.

- **Smoke Detectors** - This is a perfect time of year to change the batteries in your smoke detectors. "According to the National Fire Protection Association, approximately three out of five fire deaths occur in homes without functioning smoke detectors. It is recommended to have a smoke detector inside each bedroom and on every level of the home including the basement. Make sure the smoke detectors are tested monthly and replaced every 10 years." (Wisconsin Emergency Management, 2018)
- **Carbon Monoxide Detectors** - Make sure you have battery – operated or battery backup CO Detectors near every bedroom and check them monthly to ensure they are functioning properly. This is a great time to change the batteries in each unit.
- **72 Hour Emergency Preparedness Kits and First Aid Kits** - Be sure to have a basic emergency kit in your home with supplies, food and water to last you and your family for at least three days, or 72 hours. Other items like a battery-operated radio, flashlights, additional batteries, and first aid kit should also be included. Update your vehicle emergency kits to reflect the current and approaching seasons.
- **Emergency NOAA Weather Radio** - Spring brings the increased threat of tornadoes and severe storms. Make sure you have an emergency weather radio. It's like having a tornado siren in your home. When it goes off, go to a safe place!
- **National Weather Service Wireless Emergency Alerts** – Wireless Emergency Alerts (WEA) are emergency messages sent by authorized government alerting authorities through mobile carriers. Government partners include local and state public safety agencies, FEMA, the FCC, the Department of Homeland Security, and the National Weather Service. No signup is required! Alerts are sent automatically to WEA-capable phones during an emergency.

## SEX OFFENDER RELEASE - COMMUNITY NOTIFICATION

### Community Notification Meeting

**Date:** March 13, 2018; 6-7 p.m.

**Location:** Beloit Historical Society, 845 Hackett St., Beloit, WI

The Wisconsin Department of Health Services has notified the Beloit Police Department that Kenneth R. Cairns, 67, will be released by March 23, 2018, and he will reside at 2219 Euclid Ave, Beloit, WI. The purpose of this notification is to ensure safe neighborhoods by informing the public when a sex offender is released into the Beloit Community. On June 1, 1997, Wisconsin State Statute 301.45 (Act 440), the Sex Offender Registration and Community Notification Law, took effect to enhance public safety and protection.

The Beloit Police Department, in collaboration with WI Department of Corrections, WI Department of Health Services, and Rock County Human Services, will be holding a community notification meeting to provide information on Kenneth Cairns. The meeting will provide information on the sex offender registry and notification law, education on protecting yourself and others from sex offenders and the supervision release plan for Cairns.

Cairns' targeted victims were juvenile males.

While residing at 2219 Euclid Ave., conditions of Cairns' supervision include, but are not limited to:

- For the first year of supervised release: restricted to the person's residence except for outings approved by the Department of Health Services that are under the direct supervision of a Department of Corrections escort and that are for employment or volunteer purposes, religious purposes, educational purposes, treatment and exercise purposes, supervision purposes, or residence maintenance, or for caring for the person's basic living needs.
- Cooperate with the community reintegration team in implementing the Supervised Release Plan.
- No unapproved activities in the community without prior approval of the DCC Supervising Agent Richard Fetting.
- No contact with minors.
- No contact with victims.
- No patronizing taverns, bars or liquor stores.
- Not to consume alcohol or drugs.
- Comply with requirements of lifetime Sex Offender Registration.
- Comply with requirement of lifetime GPS monitoring.
- DCC will conduct random compliance checks for compliance.

The Beloit Police Department expects Cairns will cooperate and comply with the above conditions and rules. If you observe any violations, please contact the Beloit Police Department at the non-emergency number 608-757-2244.



The observers may observe the process of absentee ballot distribution in the common areas of the home, facility, or complex.
