SUMMARY

The City of Beloit is seeking proposals from qualified and experienced consultants to perform an audit of city-owned facilities to determine compliance with Americans with Disabilities Act (ADA) 2010 design standards.

PROPOSALS MUST BE RECEIVED NOT LATER THAN 12:00 P.M. ON MONDAY, JULY 15, 2019.

The City of Beloit reserves the right to accept or reject any or all proposals, to waive any irregularities, informalities or defects in any proposal, to accept any proposal in whole or in part which shall be deemed in the best interests of the City of Beloit, and to negotiate with the successful proponent.

PROCESS

The City of Beloit will conduct the review, screening and selection of a professional consultant to provide the services required. The consultant is encouraged to suggest or incorporate additions or modifications to the scope into the proposal that will enhance or clarify the study.

RFP SUBMISSION

Only complete responses will be considered. The sealed envelope shall be marked City of "Beloit – ADA Facility Audit". A total of 2 copies of the response must be provided in hard copy by 12:00 p.m. on Monday, July 15, 2019, delivered by mail or in person to:

PROJECT BACKGROUND

The City of Beloit has a population of approximately 36,000. It has 44 parks with a variety of public buildings and recreational facilities. The city also has 76 buildings that house a variety of uses and with varying levels of general public access. Tables of the sites are attached as Exhibits A and B.

PROJECT GOALS

1. Provide an evaluation of City facilities including buildings and playgrounds.
2. Provide a spreadsheet and transition plan that can be used to track proposed modifications with the ability for the City to adjust timeframes and priorities.
3. Provide the City with a cost estimate for remediation work required as a result of the evaluations.

SCOPE OF SERVICES

1. Meet with City staff to review study objectives.
2. Provide a field review of all City buildings and parks to evaluate compliance with ADA regulations and provide remedial options for compliance.
3. Provide a report, including cost evaluation, of all proposed modifications, recommended priorities for completion of proposed modifications, and a tabular listing of recommended or proposed modifications separated by the categories of facilities, park buildings and park playgrounds.
4. Provide a spreadsheet that can be utilized to provide detailed modifications, costs, and priorities for the transition plan.
5. Present the report and spreadsheet at a meeting of the City's ADA team and to the Parks & Recreation Management.

SPECIFICATIONS FOR PROPOSAL

Note: All proposals and copies shall be 8 1/2 by 11" and shall be bound.

The RFP respondent shall submit two (2) copies of the RFP response with all of the information requested. Proposal shall be in an envelope clearly labeled "City of Beloit - ADA Facility Audit". In order to simplify the proposal evaluation process, the City is seeking RFP responses in the following format:

1. Cover letter
 - a) Include the name, address and telephone number of your company.
 - b) Include the name and email address of the direct contact person for this proposal.
2. Company Overview
 - a) A brief description of the qualifications and experience of your firm. Include personnel qualifications, experience and availability.
 - b) Names and qualifications of outside consultants and associates that will be employed to assist on this project.

3. Relevant Experience
 - a) Your current and past experience as it relates to the scope of this request for proposal.
 - b) References of other Municipalities/Organizations that your firm has prepared or assisted in preparation of work similar to that involved in this request for proposal.
 - c) Municipal government experience. Preference will be given to respondents who have developed plans for other Wisconsin communities.
4. Support Team
 - a) Identify the individuals comprising the support team, experience/biography and what specific role each will take in completing the work.
5. Project Approach
 - a) Describe your approach for completing the tasks identified in the Scope of Services section.
 - b) Discuss proposed additions or modifications to the scope presented herein.
6. Timeframe for completion
 - a) The timeframe for completion of the project will be evaluated. The Consultant shall also demonstrate the ability to commit time and resources to the City's project relative to its other commitments.
7. Assistance from City
 - a) To the greatest extent possible, identify the types of information, data and assistance expected from the City in order to complete this project.
8. Project Cost
 - a) Identify the cost for each task in the Scope of Work. Include the number of staff needed to complete each task, as well as the cost.
 - b) Any additional costs/charges (such as travel expenses) must be clearly defined in the proposal.
 - c) Complete summary of costs – cost by tasks, by staff person, components, optional work, taxes, etc.
 - d) Provide a Certificate of Insurance.

EVALUATION CRITERIA

1. Staff will evaluate the proposals. If there is no clear choice, a short list of consultants will be invited for an interview. The proposals and oral interview results shall be the basis of selection. The selection criteria are as follows:
 2. Consulting firms that are the most qualified and experienced to perform the work specific in this request for proposal.
 3. The quality of the proposal and adherence to the proposal requirements.
 4. Demonstrated understanding of the scope of work in the request for proposal.
 5. The experience of the project manager and work team.
 6. Past record of performance as determined from all available information, including direct communication by the City with consultant's former clients. Factors to be considered include, but may not be limited to: experience and familiarity with similar types of projects, cost control, work quality and completion of work on schedule.
 7. The ability to perform work in a timely manner.
 8. The quality of the interviews, if necessary.

GENERAL NOTES

1. This Request for Proposals does not constitute a contract or an offer of employment. The cost of preparation of proposals shall be the sole obligation of the consultant. All proposals, whether accepted or rejected, shall become the property of the City.
2. In all cases where an electronic spreadsheet, document or database has been created to develop the study, the bidder shall provide a copy of such spreadsheet in native electronic form. The City presently uses Microsoft Excel and Word and requires spreadsheets and documents created or able to be translated into those formats. The final report will be furnished on paper, and in an Adobe .pdf format.
3. All completed work including draft reports, related documents, ancillary reports and the final report, whether in written, video or electronic formats, becomes the property of the City at the end of the project and will be turned over to the City.
4. Award will be made by the City of Beloit. The City of Beloit reserves the right to accept or reject any or all proposals, to waive any irregularities, informalities or defects in the proposals, to accept any proposal in whole or in part which it shall deem to be in the best interest of the City of Beloit.
