### CHRISTMAS TREE, HOLIDAY WREATH AND GARLAND COLLECTION

The Recycling Drop Off Center at 2351 Springbrook Court will be **CLOSED** on Saturday, January 4.

If you’re not sure whether to place holiday packaging and wrappings into recycling or garbage, follow these guidelines:

- **Recycle:** Paper-based wrapping paper, cardboard boxes (cut down to 3’ x 3’), and cardboard shipping blocks.

- **Garbage:** Foil/metallic wrapping paper, ribbon, bows, tape, clear plastic packaging from toys, bubble wrap (or return to a local shipping store for reuse/save if you're moving in the future), inflated plastic bags, Styrofoam shipping blocks, and foam peanuts.
- Holiday wreaths and garlands can be disposed of in your trash cart.

### **Christmas Tree Collection**

- Curbside Christmas tree collection runs Monday, January 6, 2020, through Friday, January 17, on your regularly scheduled solid waste collection day.
  - ◇ Place your tree on curbside by 6 a.m. on your trash day.
  - ◇ Tree must be free of any stands, bags, lights, garlands and ornaments, etc.
- Christmas trees are accepted at the Recycling Drop Off Center, 2351 Springbrook Court, on Saturdays from 9 a.m. to noon, beginning January 11, 2020.

### **LATHERS ROAD BORROW MATERIALS SITE**

In mid-December 2019, Rock Road purchased roughly 100 acres of property in the City of Beloit located at 2320 South Lathers Road, known as the "Suppes parcel." Rock Road's plan is to remove 300,000 cubic yards of "borrow materials," which are rock and/or soil, sand, silt, clay, gravel and the like in a phased approach through 2022 in conjunction with the Interchange project.

Rock Road is claiming that under Wis. Stat. 85.193 the City has no regulatory authority because the property is going to be used for a state transportation project. The City of Beloit had no prior knowledge of the sale of the property or the proposed use. If Rock Road's assertion is correct, the City would not have any local permitting or other oversight. The State of Wisconsin would supersede local authority in this circumstance. We are currently reviewing Rock Road's claim of exemption from local authority but upon initial evaluation it appears their claim of exemption is likely consistent with the statute.

The property is currently zoned as a development holding, primarily intended for future residential use. The expectation is that the property will be available for future residential development upon the completion of the Interchange project, with restoration of the property to be completed by 2023. As part of the Community Development Block Grant program, recipients such as the City of Beloit are required to have a citizen participation plan. This proposed plan will update the language to be in accordance with the Federal Regulation. Language has been updated to be more inclusive in regards to the individuals and groups that may be concerned with CDBG programs and/or activities.
- c. Consideration of Resolution 2020-002 approving an Underground Electrical Easement to Wisconsin Power & Light on the property located at 1111 Elaine Drive. Plan Commission recommendation for approval 6-0.  
Wisconsin Power and Light Company has requested a 12-foot wide easement to the transformer on City owned property. The proposed easement will allow for the installation of a new underground electric line from the transformer pad out to the right-of-way. An existing electric line will be retired.
- d. Referral to Plan Commission: Application for a Certified Survey Map for the property located at 1452 Townhall Road. The intent of the proposed CSM is to create lots for future subdivision Plats 4 and 5 of Eagles Ridge.
- e. Consideration of Resolution 2020-006 allowing Beloit Police Department to apply for Mobile Field Force—Gas Mask 2020 Grant to purchase gas masks and related equipment.  
The Beloit Police Department has an established mobile field force team to respond to public assemblies or demonstrations. The current mobile field force masks and filters are outdated and in need of replacement. Wisconsin Emergency Management has provided available grant funding to purchase protective masks, filters, and bags for mobile field force teams.

Rock County Impaired Driving Enforcement Task Force**

**Jan. 3, 2020** - Officers from the Beloit Police Department will be participating in the Rock County Impaired Driving Enforcement Task Force on the following dates during January:

- Saturday, January 4
- Saturday, January 11
- Friday, January 17
- Saturday, January 25

During this additional enforcement, the Beloit Police Department will have more officers on patrol to discourage people from driving while impaired. The Beloit Police Department will have zero tolerance for driving under the influence, open intoxicants, seatbelt violations and improper use of child safety restraints.

“Our goal is send the message that driving under the influence puts the lives and safety of others at risk,” said Sgt. Christian Dalton. “We hope this enforcement will help reduce the number of people who choose to drive while impaired.”

Driving under the influence includes the use of alcohol, illegal drugs or prescription medication. The Beloit Police Department suggests all motorists take steps to protect themselves and others:

- Ensure everyone in your vehicle is buckled up - every day, every trip. Watch your speed, be patient and alert.
- If you plan to use any alcohol, drugs or prescription medication that will impair your driving, choose a sober designated driver.
- If you’re feeling buzzed, you likely are over the 0.08 BAC limit and should not drive. Take public transit, a taxicab, or ask a sober friend to drive you home.
- The Wisconsin DOT offers a free [Drive Sober mobile app](#) that includes a blood alcohol estimator, designated driver selector, and find-a-ride feature that uses a smart phone’s GPS to locate alternative transportation.
- Some taverns and restaurants have programs to provide patrons with a safe ride home. Visit [www.tlw.org/](http://www.tlw.org/) and click on Safe Ride.
- Report impaired drivers to law enforcement by calling 911. Provide as much detail as possible on the driver, vehicle, and location.

The Rock County Impaired Driving Enforcement Task Force includes the Rock County Sheriff’s Department and the Janesville, Town of Beloit, Orfordville and City of Beloit police departments. Funding for the special enforcement periods is provided via a grant from the Wisconsin Department of Transportation.
