- Chickens may not be acquired, kept, or harbored until a valid permit has been issued.
- Annual permit fee is \$35 (\$70 if chickens and/or coop preceded permit)
- Roosters are prohibited.
- Slaughtering is prohibited.
- Chickens must be kept in the coop or run at all times.
- Registration with the Wisconsin Department of Agriculture, Trade, and Consumer Protection is required.
- Chicken permits will not be issued for properties and/or applicants with delinquencies.
- All of the applicable regulations can be found in Section 7.244 of the Code of General Ordinances.

The applicant certifies that all of the above information is true and correct, and agrees to complete the work described according to the information given, the plans filed, and to be in full compliance with all applicable laws, codes, rules and regulations of the City of Beloit and the State of Wisconsin. This permit is valid for this year; deadlines contained therein are always subject to any shorter deadline contained in an order imposed by the Community Development Department.
